And I'll sign on 19 behalf of the Commission. 20 And then we do have on the agenda for today the 21 Application of the New Mexico Oil Conservation Division through the Environmental Bureau Chief for repeal of Rules 22 23 18, 105 and 313 and adoption of a new rule regulating pits, 24 and this case is going to be continued, at the request of

the Division, until the Commission Hearing on September

25

11th, 2003.

We also had a couple of applications, Case
13,048, the Application of Devon Energy Production Company,
L.P., for compulsory pooling in Lea County, New Mexico and
Case 13,049, the Application of EGL Resources, Inc. for
compulsory pooling in Lea County, New Mexico. These two
cases are being heard *de novo* by the Commission.

We did receive a motion to vacate this hearing in those two cases, which motion we granted, and that means that we will be rescheduling the hearing in these cases after the completion of a related Division hearing. That's basically what's at work there. Right Ms. Bada?

MS. BADA: Yes.

CHAIRMAN WROTENBERY: Okay. So we won't be doing anything further on those today, or until the Division hearing process is completed.
