Dear Ms Prukop:

Marbob Energy Corporation filed an application for a permit to drill its proposed Pretty View Com Well No. 1 within the Potash Area in the SE/4 SW/4 of Section 2, Township 20 South, Range 30 East, NMPM, Eddy County, New Mexico. The application was set for hearing as the result of an objection from Intrepid Mining NM, LLC (formerly Mississippi Potash, Inc.)

Intrepid Mining has now withdrawn its objection to Marbob's application for permit to Drill. Enclosed are copies of two letters to the New Mexico State Land Office from Intrepid Mining. The first letter, references the OCD Hearing in Case 13232 and states that it "will not appear at the hearing." The second letter references Marbob's proposed well and states that Intrepid Mining is "withdrawing its objection to the proposed well location."

Since there is no longer an objection from an affected potash operator, Marbob Energy Corporation requests that its application be administratively approved and that, pending approval of this application by the Division's District Office in Artesia, this case be continued to the April 29, 2004 examiner hearing docket.


