**Ed Haseley, Direct Testimony:**

Provide all notes, photographs, videotapes, logbooks, measurements, field audits, instrument calibration data, and similar documentation developed by Mr. Hasely or under Mr. Hasely's direction during his supervision of the remediation work, as referred to on Page 9 of Mr. Hasely's direct testimony.

Provide all notes, photographs, instrument readings, instrument calibration data, videotapes, logbooks, field audits, and similar documentation developed by Mr. Hasely or under Mr. Hasely's direction as referred to on Page 8, lines 8 and 9 (reference to nine or ten test holes excavated in the vicinity of Burlington's former production pit and a PID survey), including all contemporaneously developed data on the test hole locations, depths, sampling locations, and results.

Provide the correspondence that transmitted the actual data support (boring logs and PID readings) to OCD that was claimed to have been transmitted in Burlington Exhibit 21 (data from two soil borings, SB-1 and SB-2), but that were not included with the Exhibit.

All field notes, photographs and other documents provided to Burlington Resources by Philip Services Corp. relating to the Hampton 4M well site

**James Rhodes – Rebuttal Testimony:**

Provide the performance analysis referred to by Mr. Rhodes and upon which Mr. Rhodes bases his testimony at page 4, lines 4 and 5.

**Paul Rosasco - Direct and Rebuttal Testimony:**

Provide copies of all site-specific cross-sections, photographs, survey data, analytical chemistry data, data summaries, notes or logs from Mr. Rosasco's field and first-hand observations of the remediation and other on-site work at the Hampton 4M, and copies of all quantitative analyses that Mr. Rosasco relied upon for conclusions in your direct and rebuttal testimony.

**Larry Dillon - Rebuttal Testimony:**

Provide all bradenhead, mechanical integrity, and other test protocols and the results from those tests that were performed at the Hampton 4M site.

Provide all test results supporting Mr. Dillon's testimony on page 3 that the tanks and their associated piping had no leaks (e.g., tightness testing, hydrostatic testing, or other approved tank/piping tightness testing).

**BURLINGTON RESOURCES OIL & GAS COMPANY'S  
MOTION TO QUASH SUBPOENA DUCES TECUM**

---

Burlington Resources Oil and Gas Company ("Burlington"), moves the New Mexico Oil Conservation Division to quash the subpoena issued on behalf of Public Service Company of New Mexico ("PNM"), on August 23, 1999. The subpoena should be quashed because it seeks information to which PNM has had access throughout this matter, and because it is unduly burdensome, being served two days before a response is due, and three days before the hearing on the merits in this matter. In support of this Motion, Burlington states:

1. The hearing on the merits in this matter is scheduled to begin on Thursday, August 26, 1999.

2. Since the Division's Order, which is the subject of this *de novo* review by the Commission, was issued in this matter on February 5, 1999, Burlington has made available all information which PNM has from time to time informally requested. Burlington has not refused any informal discovery requests made by PNM in this matter since the February 5, 1999 Order.

3. PNM has made no formal discovery in this matter since the Division's Order was issued in this matter on February 5, 1999.

4. PNM has not sought the particular information requested in its August 23, 1999 subpoena, either through formal or informal discovery in this matter.

5. In the August 23 subpoena, PNM seeks eight categories of information from four Burlington witnesses. The information sought by PNM is substantial and will necessitate Burlington's full attention to the subpoena, to the detriment of Burlington's preparation for the August 26, 1999 hearing on the merits.

6. If PNM needed the information requested for its hearing preparation, it could have asked Burlington for that information six months ago, or three months ago, or a month ago, or even a week ago. PNM did not seek that information. Instead, it waited until three days before the hearing, made no telephone calls or attempts to cooperate with Burlington's counsel, and obtained a subpoena which provides Burlington less than 48 hours to compile

and produce information from four different witnesses.


7. Having made no attempt to discover the information sought in the subpoena through formal or informal discovery, PNM's attempt to use a subpoena to discover substantial amounts and categories of information, a mere three days before the hearing on the merits in this action, is a blatant attempt to abuse the Commission's compulsory process for the purpose of harassment. Burlington submits that the Commission should refuse to participate in PNM's harassment and attempts to divert Burlington from its hearing preparation.

Therefore, because the subpoena issued by the Division on behalf of PNM on August 23, 1999, is unduly burdensome and an abuse of the Commission's subpoena power, Burlington respectfully requests that the subpoena be quashed.




