PROPOSED ADVERTISEMENT

Case 13255: Application of JTD Resources, LLC for compulsory pooling and unorthodox oil well locations, Lea County, New Mexico. Applicant seeks an order pooling all mineral interests from the surface to the base of the Abo formation underlying the NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 2, Township 20 South, Range 38 East, NMPM, to form a standard 40-acre oil spacing and proration unit for any and all formations and/or pools developed on 40-acre spacing within that vertical extent, including but not limited to the Undesignated House Yates-Seven Rivers Pool, Undesignated House-San Andres Pool, Undesignated House-Blinbry Pool, Undesignated House-Tubb Pool, Undesignated House (Drinkard) Pool, and Undesignated House-Abo Pool. The unit is to be dedicated to applicant's White Owl Well No. 1, to be drilled from an orthodox surface location 500 feet from the north line and 330 feet from the west line of Section 2, to a bottomhole location approximately 1310 feet from the north line and 330 feet from the west line of Section 2. The well will be unorthodox in the Tubb, Drinkard, and Abo formations. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of Capataz Operating, Inc. as operator of the well, and a 200% charge for the risk involved in drilling and completing the well. The units are located approximately 2 miles southeast of Nadine, New Mexico.
