Gentlemen:

By letter dated April 7, 2004 Devon Energy Production Company, L.P. proposed the formation of a standard 320-acre gas spacing unit consisting of the E/2 of Section 15-T23S-R34E, Lea County, New Mexico and the drilling of the Mad Dog 15 Federal Com #1 well. Not all working interest owners elected to participate in said well or otherwise commit their interest in the spacing unit.

In response, Devon filed for compulsory pooling with the New Mexico Oil Conservation Division. Case No. 13286 was heard June 24, 2004 and Compulsory Pooling Order R-12175 was issued July 22, 2004. Enclosed is a copy of the Order and Devon's AFE reflecting estimated dry hole costs to be \$3,126,031 and completed well costs to be \$3,995,342. Please make your election in accordance with the provisions of said Order within the time frame prescribed.
