

MEMORANDUM OF TERM ASSIGNMENT AND AGREEMENT

STATE OF NEW MEXICO }

COUNTY OF LEA }

WHEREAS, By Term Assignment and Agreement (hereinafter called "Assignment") dated the 11th day of May, 2004, ConocoPhillips Company, a Delaware corporation, with an operating office at P. O. Box 2197, WL3, Houston, TX 77252-2197 (hereinafter called "COPC"), assigned and transferred to Nearburg Exploration Company, L. L. C., 3300 North "A" Street, Building 2, Suite 120, Midland, TX 79705 (hereinafter called "Assignee") the oil, gas and casinghead gas and all rights pertaining thereto in the oil and gas lease(s) and lands described in Exhibit "A" (hereinafter called "lease acreage").

Assignee shall have the option but not the obligation to drill a well or wells for oil and/or gas located on the lease acreage or acreage pooled therewith on or before May 11, 2006. If Assignee does not commence the actual drilling of such well on or before said date, and/or conduct any additional operations as provided for in the Assignment, then and thereupon the Assignment of the lease acreage shall terminate except as provided for therein.

The Assignment reserves, excepts and retains to COPC an overriding royalty interest equal to Twenty Percent of 8/8ths (20% of 8/8ths), less and except any royalties, overriding royalties, or other burdens on production existing as of the date of the Assignment. COPC's reserved interest applies to all extensions and renewals of the oil and gas lease(s) subject to said Assignment. The Assignment also provides that COPC retains a call on production, a preferential right to purchase and other specific rights designated therein, including but not limited to the right of COPC to file of record a Notice of Termination designating lease acreage which is no longer covered by the Assignment.

WHEREAS, said Assignment is unrecorded and the parties desire an instrument in recordable form as a memorandum of such Assignment;

NOW, THEREFORE, for and in consideration of the premises it is agreed that this Memorandum of Term Assignment and Agreement be executed for notice purposes to be filed in the Lea County, New Mexico records.

The terms and provisions of said unrecorded Assignment are referred to and incorporated herein, and made a part hereof to the same extent as though set out verbatim. Should any conflict arise between the terms of this Memorandum and the Assignment referred to hereinabove, the terms of the Assignment shall control.


