

APPLICATION

Samson Resources Company applies for an order abolishing the Special Rules and Regulations for the Teas-Pennsylvanian Gas Pool (the "Pool"), and in support thereof, states:

1. Applicant is an operator in the Pool, which was created by Oil Conservation Commission Order No. R-2627, dated December 27, 1963. The Pool currently encompasses the following acreage:

Township 20 South, Range 33 East, N.M.P.M.
Section 11: All
Section 12: W½
Section 14: N½

2. Special Rules and Regulations for the Pool were adopted by Commission Order No. R-2627, as amended. The rules require (a) 320 acre well units, and (b) wells to be located no closer than 990 feet to the outer boundary of a well unit nor closer than 330 feet to a quarter-quarter section line.

3. Applicant requests that the Special Rules and Regulations for the Pool be abolished, and that the Pool henceforth be governed by the Division's statewide rules.

4. The granting of this application is in the interests of conservation, the prevention of waste, and the protection of correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the relief requested above be granted.
