### APPLICATION

HEC Petroleum, Inc. applies for an order amending the special rules and regulations of the Catclaw Draw-Morrow Gas Pool (the "Pool"), and in support thereof, states:

- 1. Applicant is a working interest owner and operator in the Pool.
- 2. The Pool was created by Commission Order No. R-4157, and currently covers the following lands in Eddy County, New Mexico:

Township 21 South,	Range	25 East,	N.M.P.M.
Section 1:	Lots	1-16 and	S½ (All)
Section 2:	Lots	1-16 and	S½ (All)
Section 11-14:	All		
Section 23-28:	All		
Section 34-36:	All		

Township 21 South, Range 26 East, N.M.P.M. Section 19: All

- 3. Commission Order No. R-1670-O, as amended by Commission Order No. R-4157-B, as amended, instituted special rules for the Pool, providing for:
  - (a) 640 acre spacing;
  - (b) two wells per well unit, to be located in different quarter sections;
  - (c) initial wells to be located no closer than 1650 feet to the outer boundary of the section, nor closer than 330 feet to a quarter-quarter section line; and
  - (d) second wells to be located no closer than 1650 feet to the outer boundary of the section, nor closer than 330 feet to a quarter-quarter section line, nor closer than 990 feet to any existing Morrow well in the well unit.

- 4. Applicant requests amendment of the special pool rules for the Pool to provide for the following:
  - (a) 640 acre well spacing;
  - (b) four wells per well unit, provided that no more than one well shall be allowed per quarter section;
  - (c) orthodox well locations no closer than 660 feet to a quarter section line, nor closer than 10 feet to a quarter-quarter section line or subdivision inner boundary; and
  - (d) the operator of all wells in a well unit shall be the same.
- 5. The granting of this application is in the interests of conservation, the prevention of waste, and the protection of correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the relief requested above be granted.
