WHEREUPON, the following proceedings were had at 1 2 9:53 a.m.: EXAMINER JONES: And let's call Case 13,364, 3 4 Application of Mewbourne Oil Company for compulsory pooling, Eddy County, New Mexico. 5 Call for appearances. 6 7 MR. BRUCE: Mr. Examiner, Jim Bruce of Santa Fe 8 representing the Applicant. I have one witness. EXAMINER JONES: Any other appearances? 9 Will the Applicant please stand to be sworn -- or 10 the witness, please stand to be sworn? 11 (Thereupon, the witness was sworn.) 12 D. PAUL HADEN, 13 the witness herein, after having been first duly sworn upon 14 his oath, was examined and testified as follows: 15 DIRECT EXAMINATION 16 BY MR. BRUCE: 17 Would you please state your name for the record? 18 Q. My name is Paul Haden. 19 Α. Where do you reside? 20 Q. 21 I reside in Midland, Texas. Α. Who do you work for and in what capacity? 22 Q. I work for Mewbourne Oil Company as a senior 23 Α. landman. 24 Have you previously testified before the 25 Q.

Division? 1 2 Α. Yes, I have. 3 Q. And were your credentials as an expert petroleum landman accepted as a matter of record? 4 5 Α. Yes, they were. And are you familiar with the land matters 6 ο. 7 involved in this Application? Yes, I am. Α. 8 MR. BRUCE: Mr. Examiner, I'd tender Mr. Haden as 9 an expert petroleum landman. 10 EXAMINER JONES: Mr. Haden is gualified as an 11 expert petroleum land manager. 12 (By Mr. Bruce) Mr. Haden, could you go to your Q. 13 exhibit booklet and go to Exhibit 1 and describe briefly 14 what is shown by that exhibit? 15 Exhibit Number 1 is a land plat of the area, more A. 16 specifically of Township 18 South, Range 28 East, in Eddy 17 County, New Mexico. 18 It also indicates our proposed spacing unit, 19 20 being the east half of Section 26. That designation is 21 outlined in yellow. 22 It also indicates our proposed well location, 23 which is indicated by a red dot, which location is 660 from the north line and 1650 feet from the east line of Section 24 26. 25

1 Q. And you seek to force pool units spaced on 320 2 acres, correct? That's correct. 3 Α. And the northeast quarter for 160-acre units? 4 Q. 5 Yes, sir. Α. 6 And the west half, northeast quarter, I believe, Q. for 80-acre units? 7 8 Α. That's correct. MR. BRUCE: And I think, Mr. Examiner, there is 9 an 80-acre pool, the Travis-Upper Pennsylvanian Pool --10 EXAMINER JONES: Okay. 11 MR. BRUCE: -- within a mile. 12 And Mr. Examiner, the advertisement also lists 13 the -- no, I'm sorry, I was looking at the wrong thing. 14 We are not seeking to force pool any 40-acre units in this 15 16 well. 17 (By Mr. Bruce) What is the footage location of Q. 18 the well, Mr. Haden? It's 660 from the north line and 1650 feet from 19 Α. the east line --20 21 Q. Okay. -- of Section 26. 22 Α. What is the ownership of the well unit? And I 23 Q. refer you to your Exhibit Number 2. 24 25 Α. Exhibit Number 2 indicates the ownership in the

1 respective tracts, of which all the east half consists of 2 state minerals. It indicates more specifically the unit 3 ownership on the bottom of the plat. 4 ο. For the 320-acre unit? 5 Yes, sir, for the 320 acres. Α. Okay, and Mewbourne is the largest. Of these 6 Q. 7 parties, who does Mewbourne seek to force pool at this 8 time? Mewbourne seeks to force pool Devon Energy 9 Α. Corporation as to their 12-1/2-percent unit interest, also 10 Xeric Oil and Gas Corporation as to their 12-1/2-percent 11 interest, and also the T.J. and Mary Ray Sivley Trust as to 12 their 4.6875-percent unit interest. 13 Okay. One thing, with respect to an 80-acre 14 0. 15 unit, Xeric would have 50 percent of that unit; is that 16 correct? That's correct. 17 Α. 18 Okay. Now, you are continuing to work with these Q. 19 people, correct? 20 Α. Yes, we are. 21 Q. And if you obtain their voluntary joinder, will you notify the Division? 22 23 Absolutely. Α. 24 Q. Okay. Oh, and on page 2 of this exhibit, you 25 have broken down the 160- and 80-acre well units also?

Yes, I have, as to the percentage ownership in 1 Α. each one of those units. 2 3 Q. Okay. Let's discuss Mewbourne's efforts to 4 obtain the voluntary joinder of these interest owners. 5 Would you move to your Exhibit 3 and briefly go over that 6 exhibit? Exhibit Number 3, first off, gives a summary of 7 Α. my communications with the poolees. It lists Devon Energy 8 9 Corporation, Xeric Oil and Gas Corporation, and also lists Yates Petroleum Corporation, who we are dismissing as they 10 11 have executed our AFE and operating agreement. And also it 12 lists the communications with Bank of America, which they are the trustee for the T.J. and Mary Ray Sivley Trust. 13 When were these parties first contacted, 14 ο. 15 approximately? 16 Devon Energy was contacted with a -- they were Α. sent a letter via certified mail September 8th, '04. Xeric 17 18 Oil and Gas Corporation was mailed a letter August 19th, 19 '04, actually to Mr. Ronald R. Miles, who was Xeric's land 20 broker at the time they acquired this interest at a state 21 land sale. Also on August 18th, '04, the Sivley trust sent 22 a letter proposing the well, with AFE enclosed. 23 And were follow-up contacts made with these Q. parties? 24 25 Α. Yes, they were.

1	Q. And are those summarized in Exhibit 3?
2	A. That's correct.
3	Q. And are copies of the actual written letters and
4	your handwritten notes included as backup in Exhibit 3?
5	A. Correct.
6	Q. In your opinion, has Mewbourne made a good-faith
7	effort to obtain the voluntary joinder of the interest
8	owners in the well?
9	A. I think we have.
10	Q. Could you identify Exhibit 4 and discuss the cost
11	of your proposed well?
12	A. Exhibit Number 4 is an AFE of our proposed
13	Beretta 26 State Com Number 1 well. It's an 11,000-foot
14	test. It lists a dryhole cost of \$732,600, a completed
15	well cost of \$1,232,900.
16	Q. And is this cost in line with the cost of other
17	wells drilled to this depth in this area of Eddy County?
18	A. That's correct.
19	Q. Does Mewbourne request that it be designated
20	operator of the well?
21	A. Yes, sir.
22	Q. Do you have a recommendation for the overhead
23	rates?
24	A. We're recommending overhead rates for drilling,
25	\$6000, and producing well rate of \$600 per month.

And are these amounts typical to those normally Q. 1 charged by other operators for wells in this area of this 2 3 depth? Yes, sir, as well as those parties who have 4 Α. executed our operating agreement dated October 13th of '04. 5 Q. Do you request that any overhead rate provided 6 7 for in the order be adjusted periodically under the COPAS accounting procedure? 8 9 Α. Correct. And do you request that the maximum cost-plus-10 Q. 200-percent risk charge be assessed against any 11 nonconsenting interest owners? 12 13 Α. We so request. 14 Q. And finally, were the nonconsenting interest 15 owners notified of this hearing? 16 Α. Yes, sir. 17 Q. And is that shown on Exhibit 5? 18 Α. That's correct. 19 Were Exhibits 1 through 5 prepared by you or Q. 20 under your supervision or compiled from company business 21 records? 22 Α. They were. 23 Q. And in your opinion is the granting of Mewbourne's Application in the interests of conservation 24 25 and the prevention of waste?

Α. Yes. 1 MR. BRUCE: Mr. Examiner, I'd move the admission 2 3 of Exhibits 1 through 5. 4 EXAMINER JONES: Exhibits 1 through 5 will be 5 admitted to evidence. 6 MR. BRUCE: That's all I have. 7 EXAMINATION BY EXAMINER JONES: 8 I'm sorry, Mr. Haden, will you state one more 9 Q. 10 time the companies that -- or the entities that have not 11 signed so far? You said Xeric, T.J. --12 Α. Xeric Oil and Gas Corporation, Devon Energy 13 Corporation, and the T.J. and Mary Ray Sivley Trust. All 14 these parties have indicated they want to participate, 15 however they have not signed an AFE or operating, and we're 16 continuing to work with them. 17 Q. Okay. And the original Application, did it ask 18 for the 40 acres? 19 I believe it did, but actually all the parties Α. 20 are committed there. Q. So you would ask that be dropped from the --21 22 MR. BRUCE: Yeah, we do not need to force pool 23 the --24 THE WITNESS: No. 25 MR. BRUCE: -- northwest quarter, northeast

1 quarter. EXAMINER JONES: Is there any special pool rules 2 3 that we need to be aware of? MR. BRUCE: Just that Travis-Upper Penn for the 4 80-acre units. The rest are all statewide rules. 5 6 EXAMINER JONES: Okay. Gail, do you have 7 anything? 8 MS. MacQUESTEN: No questions.
