1           WHEREUPON, the following proceedings were had at  
2 8:18 a.m.:

3           EXAMINER STOGNER: This hearing will come to  
4 order. Please note today's date, October 21st, 2004, to  
5 consider Docket Number 29-04. I'm Michael Stogner,  
6 appointed Hearing Examiner for today's cases.

7           We'll go through the continuances and dismissals  
8 first.

9           On the first page, Case Number 13,357, this is  
10 the Application of Matrix New Mexico Holdings, L.L.C., for  
11 compulsory pooling, Lea County, New Mexico, this case will  
12 be continued to November 4th.

13           The next one, Case 13,358, this is the  
14 Application of RB Operating Company for two unorthodox oil  
15 well locations and simultaneous dedication, Lea County, New  
16 Mexico. This case will also be continued to November 4th.

17           On the second page, Case Number 13,326, this is  
18 the Application of Mewbourne Oil Company for compulsory  
19 pooling, Eddy County, New Mexico. This case will be  
20 dismissed.

21           On the third page, Case 13,361, this is the  
22 Application of the New Mexico Oil Conservation Division for  
23 a compliance order for a particular well in Lea County in  
24 Lea County, New Mexico. This case will be continued to  
25 November 4th.

1           The next one, 13,362, this is the Application of  
2 the New Mexico Oil Conservation Division, also for a  
3 compliance order for certain wells in Lea County, New  
4 Mexico. This case will also be continued to November the  
5 4th.

6           The last one, Case 13,363, this is the  
7 Application of the New Mexico Oil Conservation Division for  
8 an order requiring Greka AM, Inc., to bring six wells into  
9 compliance with the New Mexico Oil Conservation Division  
10 Rules and Regulations and also authorizing the Division to  
11 plug certain wells and to forfeit the applicable security  
12 and in default of compliance by a certain operator in Lea  
13 County, New Mexico. This case will be continued to  
14 November 18th.

15           Any other continuances and dismissals?

16           MR. BRUCE: Mr. Examiner, on page 2, the Samson  
17 Resources Company case, request -- the parties have come to  
18 terms but the final papers haven't been signed. Request  
19 that it be continued for two weeks, at which time I expect  
20 to dismiss it.

21           EXAMINER STOGNER: That is Samson Resources  
22 Company compulsory pooling Application, Case 13,352?

23           MR. BRUCE: Yes, sir.

24           EXAMINER STOGNER: Case 13,352 will be continued  
25 to November the 4th.


