1           WHEREUPON, the following proceedings were had at  
2 8:19 a.m.:

3           EXAMINER STOGNER: Call the hearing to order.  
4 Please note today's date, December 19th, 2002, Docket  
5 Number 40-02.

6           We will go over the continuances and dismissals  
7 on the record. I have a short announcement about today's  
8 proceedings.

9           On the first page, Case Number 12,977 -- this is  
10 the Application of McElvain Oil and Properties, Inc., for  
11 compulsory pooling, San Juan County, New Mexico -- this  
12 case will be continued to January 9th, 2003.

13           On the second page, Case Number 12,958 -- this is  
14 the Application of Arch Petroleum, Inc., for directional  
15 drilling, an unorthodox oil well location and a nonstandard  
16 oil spacing and proration unit, Lea County, New Mexico --  
17 this case has been dismissed.

18           Case Number 12,962 -- this is the Application of  
19 David H. Arrington Oil and Gas, Inc., for compulsory  
20 pooling, Eddy County, New Mexico -- this case will be  
21 continued to January 9th of 2003.

22           Is there anything that needs to be said on the  
23 record, Mr. Scott Hall?

24           MR. HALL: No, sir. Thank you very much.

25           EXAMINER STOGNER: I left a message for you

1 yesterday evening about five o'clock -- I guess you had  
2 already left -- to tell you that that had been decided,  
3 so...

4 MR. HALL: Appreciate it.

5 EXAMINER STOGNER: The next one, Case Number  
6 12,981 -- this is the Application of the Oil Conservation  
7 Division on its own motion to plug and abandon 16 certain  
8 wells in Roosevelt and Lea Counties, New Mexico -- this  
9 case will be continued to January 9th, 2003.

10 On page 3, Case Number 12,982 -- this is another  
11 Application of the Oil Conservation Division on its own  
12 motion to plug and abandon two certain wells in Eddy  
13 County, New Mexico -- this case will also be continued to  
14 January 9th, 2003.

15 Also there is a supplemental docket for today's  
16 cases involving two Ricks Exploration, Incorporated, cases.  
17 At the last hearing on December the 5th, these cases were  
18 continued on the record to today's docket. However, there  
19 was a written request to be dismissed. So at this time --  
20 that's the reason they're appearing on today's docket --  
21 Case Number 12,970 and 12,971, both Applications of Ricks  
22 Exploration, Inc., for compulsory poolings in Lea County,  
23 New Mexico, both of those cases are dismissed.

24 Are there any additional continuances or  
25 dismissals at this time?

1 MR. BRUCE: Mr. Examiner, on page 1, the  
 2 Application of Nadel and Gussman Permian, L.L.C., for  
 3 compulsory pooling, I represent the Applicant. I would  
 4 request that the case be continued to the January 9th  
 5 hearing. The parties involved are working out a voluntary  
 6 agreement, they just haven't signed up anything yet.

7 EXAMINER STOGNER: That is a compulsory pooling  
 8 matter. At this time, I'll refer that to Mr. Brooks.

9 EXAMINER BROOKS: Okay, is this the first  
 10 continuance on that or --

11 MR. BRUCE: Yes, Mr. Examiner, it has not been  
 12 continued before.

13 EXAMINER BROOKS: Okay, and you want to continue  
 14 it to January 9?

15 MR. BRUCE: Yes, sir.

16 EXAMINER BROOKS: Very good, Case Number 12,979,  
 17 Application of Nadel and Gussman Permian, L.L.C., for  
 18 compulsory pooling, Eddy County, New Mexico, will be  
 19 continued to January 9.

20 EXAMINER STOGNER: Any others? Okay.


