

**CASE 13419:**     *Application of Matrix New Mexico Holdings, L.L.C. for compulsory pooling, Lea County, New Mexico.* Applicant seeks an order pooling all mineral interests from the surface through the Wolfcamp formation in the NE/4 SE/4 of Section 10, Township 13 South, Range 38 East, to form a standard spacing and proration unit for all formations developed on 40-acre spacing within that vertical extent which includes but is not necessarily limited to the Bronco-Wolfcamp Pool. Said units are to be dedicated to its Townsend Well No. 3 to be drilled at a standard oil well location in the NE/4 SE/4 of said Section 10 to a depth sufficient to test all formations through the Wolfcamp formation. Also to be considered will be the cost of drilling and completing said well and the allocation of the cost thereof as well as actual operating costs and charges for supervision, designation of Matrix New Mexico Operating Company, L.L.C. as operator of the well and a 200% charge for risk involved in drilling said well. Said area is located approximately 3 miles southwest of Bronco, Texas.

**CASE 13420:**     *Application of Matrix New Mexico Holdings, L.L.C. for compulsory pooling, Lea County, New Mexico.* Applicant seeks an order pooling all mineral interests from the surface through the Wolfcamp formation in the SE/4 NE/4 of Section 10, Township 13 South, Range 38 East, to form a standard spacing and proration unit for all formations developed on 40-acre spacing within that vertical extent which includes but is not necessarily limited to the Undesignated Bronco-Wolfcamp Pool. Said unit is to be dedicated to its Townsend Well No. 2 to be drilled at a standard oil well location in the SE/4 NE/4 of said Section 10 to a depth sufficient to test all formations through the Wolfcamp formation. Also to be considered will be the cost of drilling and completing said well and the allocation of the cost thereof as well as actual operating costs and charges for supervision, designation of Matrix New Mexico Operating Company, L.L.C. as operator of the well and a 200% charge for risk involved in drilling said well. Said area is located approximately 3 miles southwest of Bronco, Texas.

*Application of Seely Oil Company for amendment of the remedial cementing requirements of Division Order No. R-11929 which approved waterflood operations in the EK Penrose Sand Unit, Lea County, New Mexico.* Applicant seeks an order amending Order No. R-11929 to eliminate the cementing requirements for the McElvain Federal Well No. 3 (API No. 30-025028557) located in the SW/4 SW/4 of Section 30, Township 18 South, Range 34 East. Said well is located approximately 14 miles southwest of Lovington, New Mexico.

**CASE 13421:**     *Application of Mewbourne Oil Company for compulsory pooling, Eddy County, New Mexico.* Applicant seeks an order pooling all mineral interests in all formations from the surface to the base of the Morrow in the E/2 of Section 23, Township 23 South, Range 26 East, in the following described spacing and proration units: the E/2 to form a standard 320-acre spacing and proration unit for all formations developed on 320-acre spacing within that vertical extent which includes but is not necessarily limited to the South Carlsbad-Morrow Gas Pool, the Undesignated North Black River-Atoka Gas Pool, the Undesignated Frontier Hills-Strawn Gas Pool, the Undesignated South Carlsbad-Canyon Gas Pool, the Undesignated South Carlsbad-Upper Pennsylvanian Gas Pool, and the Undesignated South Yarrow-Bone Spring Gas Pool; the SE/4 to form a standard spacing and proration unit for all formations developed on 160-acre spacing within that vertical extent; and the SE/4 SE/4 to form a standard spacing and proration unit for all formations developed on 40-acre spacing within that vertical extent which includes but is not limited to the Undesignated Dark Canyon-Delaware Pool. Said units are to be dedicated to applicant's proposed Black River Federal Com Well No. 1 to be drilled and completed at a standard gas well location 660 feet from the South and East lines (Unit P) of said Section 23. Also to be considered will be the cost of drilling and completing said well, the allocation of the cost thereof, actual operating costs and charges for supervision, the designation of Mewbourne Oil Company as operator of the well, and a charge for risk involved in drilling said well. Said area is located approximately 3 miles south of the Carlsbad Municipal Airport, Carlsbad, New Mexico.

**CASE 13422:**     *Application of Mewbourne Oil Company for compulsory pooling, Lea County, New Mexico.* Applicant seeks an order pooling all mineral interests in all formations from the surface to the base of the Morrow in the E/2 of Section 7, Township 21 South, Range 35 East, for all formations and/or pools developed on 320-acre spacing which includes but is not necessarily limited to the Undesignated Osudo-Morrow Gas Pool. Said unit is to be dedicated to applicant's proposed Osudo "7" State Com Well No. 1 to be drilled and completed at a standard gas well location 1980 feet from the South and East lines (Unit J) of said Section 7. Also to be considered will be the cost of drilling and completing said well, the allocation of the cost thereof, actual operating costs and charges for supervision, the designation of applicant as operator of the well, and a charge for risk involved in drilling said well. Said area is located approximately 10 miles southwest of Monument, New Mexico.
