2 application of Cimarex Energy Company for compulsory pooling,
3 Eddy County, New Mexico. Call for appearances.

4 MR. BRUCE: Mr. Examiner, Jim Bruce from Santa Fe
5 representing the applicant. I am submitting this case by
6 affidavit.

7 EXAMINER BROOKS: Very good.

8 MR. BRUCE: I have submitted to you Exhibits 1 and
9 2. The statements I have made with respect -- in the prior
10 case apply in this case, the only difference is that the
11 acreage being pooled from the surface to the base of the
12 Glorieta-Yeso formation is the Northeast Quarter Northwest
13 Quarter of Section 32, and the well involved is the Texas 32
14 Fee Well Number 2 which is being drilled 330 feet from the
15 North Line and 2310 feet from the West Line of Section 32.
16 And the API number for this well is 3001539083. And
17 Exhibit 2 is my affidavit of notice, again, showing that --

18 EXAMINER BROOKS: That was 39083?

19 MR. BRUCE: 39083.

20 EXAMINER BROOKS: Okay. Go ahead.

21 MR. BRUCE: -- showing that Exhibit 2, my affidavit
22 of notice, showing that COG Operating LLC and Concho Oil and
23 Gas LLC, the only other working interest owners in the well
24 unit, did receive actual notice, and I would move the
25 admissions of Exhibits 1 and 2.


