2 EXAMINER GOETZE: Okay. Case Number 15637,
3 application of Mewbourne Oil Company for compulsory
4 pooling, Eddy County, New Mexico.

5 Call for appearances.

6 MR. BRUCE: Jim Bruce of Santa Fe
7 representing the Applicant. Again, it was continued
8 only for notice purposes.

9 Exhibit 5 is an Affidavit of Notice to the
10 interest owners being pooled as to Case 15637, two
11 interest owners, John Bates and Facowie Energy. I did
12 not receive green cards back. Even as to Facowie
13 Energy, the postal service online service shows it was
14 delivered. So notice was published against those two
15 entities. So those two are Exhibits 15 and 16.

16 17 and 18 are the same thing as to Case
17 15638. In this case, John Bates did return a green
18 card, but the other two parties did not even though the
19 postal service shows that one of them did receive
20 notice. So Affidavit of -- Exhibit 18 is an Affidavit
21 of Publication showing publication against J.M. Turney,
22 Steve Turney, and Facowie Energy. So notice should be
23 complete.

24 I'd ask that Cases 15637 and 15638 be taken
25 under advisement.

1 EXAMINER GOETZE: So I'm a little confused
2 here. On Case Number 15637, Exhibit 15 has both 37 and
3 38.

4 MR. BRUCE: Yeah, operator error.

5 EXAMINER GOETZE: Oh, okay. Thank you.
