- 2 EXAMINER DAWSON: Good morning, everyone.
- 3 This is the Oil Conservation Division hearing for
- 4 December 21st, Docket Number 45-17. It's approximately
- 5 8:15. We're at 1220 South Francis, Santa Fe, New
- 6 Mexico. I'm Scott Dawson. To my right is David Brooks,
- 7 and to his right is Phil Goetze.
- 8 We'll go over the docket now.
- 9 No changes on page 1.
- 10 Page 2, number four, Case Number 15905 has
- 11 been dismissed. Case Number 15906 is continued to
- 12 January 11th, 2018. Case number six, which is Case
- 13 Number 15907, is continued to January 11th, 2018.
- Going to page 3, number nine, which is Case
- 15 Number 15748, is continued to January 11th, 2018.
- 16 Number 12, which is Case Number 15910, is continued to
- 17 January 11th, 2018.
- Going to page 4, number 16, Case Number
- 19 15887, this is one that we need to -- we wanted to ask
- 20 Mr. Bruce about.
- Is that case dismissed?
- MR. BRUCE: It is dismissed.
- 23 EXAMINER DAWSON: Okay. So Case Number
- 24 15887 is dismissed.
- Going to page 5 of 9, number 24, Case

- 1 Number 15920 is dismissed.
- 2 Going to page 6 of 9, case number 26 on the
- 3 list, which is Case Number 15800, is dismissed.
- 4 Number 28 on the list, Case Number 15806,
- 5 is there a notification -- is there some kind of a
- 6 notification issue on this case?
- 7 MS. KESSLER: Mr. Examiner, Jordan Kessler
- 8 from the Santa Fe office of Holland & Hart. There is a
- 9 notification issue with this case. We'd respectfully
- 10 request it be continued to January 11th for that
- 11 notification purpose.
- 12 EXAMINER DAWSON: Any objection?
- Okay. So case number 28 on the list, Case
- 14 Number 15806, will be continued to January 11th, 2018.
- 15 Number 29 on the list, Case Number 15872, is continued
- 16 to January 25th, 2018.
- 17 Going to page 7 of 9, number 30 on the
- 18 list, Case Number 15874, is continued to -- we were
- 19 unsure as to January 11th or 25th on this one.
- 20 MR. RANKIN: Mr. Examiner, our preference
- 21 would be to push it to the 25th for now, since we
- 22 haven't -- or we could push to the 11th and if
- 23 necessary, push it back to the 25th.
- MS. BRADFUTE: That is correct,
- 25 Mr. Examiner. I have not consulted with Mr. DeBrine,

1 who is representing them, with a preliminary offer. We

- 2 can move it to the 11th, but if we can't reach
- 3 agreement, we may need to move it to the 25th. We can
- 4 send you an email.
- 5 EXAMINER DAWSON: Okay. So that one will
- 6 be continued to January 11th. That's number 30 on the
- 7 list, Case Number 15874.
- 8 Going down on the list, numbers 31, 32 and
- 9 -- I'm sorry -- 31 and 32, Case 15782 and Case Number
- 10 15783, have been dismissed. Number 33 on the list, Case
- 11 Number 15888, is continued to January 25th, 2018.
- Going to page 8 of 9, nothing.
- Page 9 of 9, number 41 on the list, Case
- 14 Number 15773, has been dismissed. And number 42 on the
- 15 list, Case Number 15774, has been dismissed.
- 16 And I ask anyone in the room if there is
- 17 anything we may have missed.
- MR. BRUCE: Mr. Examiner, on page 5 --
- 19 EXAMINER DAWSON: Page 5.
- 20 MR. BRUCE: -- case numbers 20, 21 and 22,
- 21 M & M Energy, can we please continue those to January
- 22 11th?
- 23 EXAMINER DAWSON: Okay.
- 24 MR. BRUCE: And on page 8, the first two
- 25 Matador cases, 15889 and 15890, would you please

1 continue those to the first hearing in February, which I

- 2 believe is February 8th?
- 3 EXAMINER DAWSON: Okay.
- 4 MS. BRADFUTE: Mr. Examiner, Case Numbers
- 5 15096 and 15097, we were going to discuss Marathon's
- 6 request for an expedited order in these cases. I don't
- 7 know if you want to do it now or after one of the
- 8 breaks.
- 9 EXAMINER GOETZE: We can do that right here
- 10 and right now if you wish.
- 11 MS. BRADFUTE: Yes. We would like to
- 12 address the issue and get some clarification.
- 13 EXAMINER GOETZE: Okay. And we have other
- 14 contestants here for changes in the docket?
- 15 MR. HALL: I have a case for Case 15900.
- 16 It's continued to January 11th.
- 17 EXAMINER DAWSON: Okay. Number 34 on the
- 18 list, Case Number 15900, continued to January 11th.
- MR. HALL: Right.
- 20 EXAMINER DAWSON: Okay. And on the
- 21 question on the expedited order request, since we
- 22 have -- we kind of have a problem with the director
- 23 leaving. So we're not sure as to who the new director
- 24 is at this time.
- MS. BRADFUTE: Okay.

1 EXAMINER DAWSON: And we don't know if

- 2 we'll have a director at that time.
- 3 MS. BRADFUTE: Okay.
- 4 EXAMINER DAWSON: So we'll do our best to
- 5 get your case order expedited, but we cannot guarantee
- 6 it. So we're going to try to do what we can, but
- 7 without a new director, we're unsure at this time.
- 8 MS. BRADFUTE: Okay. Should we follow up
- 9 on that request after further developments have been
- 10 determined as to who the director's going to be?
- 11 EXAMINER GOETZE: Yeah. You can go ahead
- 12 and make a petition. I think just keep it in the
- 13 forefront of us at hearings. But at this point, because
- 14 we don't know where management is going, whoever's going
- 15 to have signature authority at this point -- we do have
- 16 an acting, and we do not who the new director is. So we
- 17 will have a void in the signing authority.
- MS. BRADFUTE: Okay.
- 19 EXAMINER GOETZE: So whether the Secretary
- 20 will take over that authority, we don't know yet. Just
- 21 be forewarned, we may have a paper, but we may not have
- 22 a signature for it.
- MS. BRADFUTE: Okay. That makes sense.
- 24 Thank you very much.
- MS. KESSLER: Jordan Kessler, Mr.

1 Examiners, on behalf of EOG. EOG does not object to an

- 2 expedited order, although the drilling dates are in
- 3 March and the hearing is in January. And so the urgency
- 4 isn't necessarily within a couple of weeks. It would be
- 5 couple of months.
- 6 MS. BRADFUTE: We would still -- our
- 7 preference would be an expedited order so everything can
- 8 be in place so the well could be drilled in the middle
- 9 of March. And we understand the Division's limitations,
- 10 of course.
- 11 EXAMINER DAWSON: So noted.
- 12 Mr. Hall?
- 13 MR. HALL: I'm representing Robert Landreth
- 14 and Advance Energy on those two cases. We're not taking
- 15 a position on expedited orders.
- 16 EXAMINER DAWSON: Okay.
- 17 EXAMINER GOETZE: Come on.
- 18 (Laughter.)
- 19 EXAMINER DAWSON: That should take care of
- 20 the docket.
- 21 If there is nothing else --
- 22 (The pre-hearing proceedings conclude, 8:25
- 23 a.m.)
- 24 (9:40 a.m.)
- 25 EXAMINER DAWSON: Okay. Moving on, we will

1 now go to number 28 on the list, Case Number 15806,

- 2 re-opened, continued from the November 30th, 2017
- 3 Examiner Hearing. It's application of the XTO Energy,
- 4 Incorporated to revise the well name and to dedicate two
- 5 additional initial wells to the nonstandard spacing and
- 6 proration unit under the terms of Order R-14478, Eddy
- 7 County, New Mexico.
- 8 Call for appearances.
- 9 MS. KESSLER: Mr. Examiner, Jordan Kessler,
- 10 from Holland & Hart. I had previously, during docket
- 11 call, requested that this be continued to January 11th.
- 12 EXAMINER DAWSON: That is correct. At this
- 13 point number 28, Case Number 15806, will be continued to
- 14 January 11th, 2018.
- Sorry I didn't catch that before.
