5 MS. KESSLER: Jordan Kessler on behalf of
6 Chisholm Operating, LLC.

7 MR. HALL: And Scott Hall, Montgomery &
8 Andrews, Santa Fe, on behalf of Great Western Drilling
9 Company and Advance Energy Partners. And I'm offering
10 our Exhibit 16.

11 EXAMINER JONES: Who wants to go first on
12 this?

13 MS. KESSLER: I think we're saying
14 essentially the same thing, Mr. Examiner. I have two
15 affidavits I've placed in front of you. The first one
16 is marked Exhibit 27. It's an affidavit from the
17 landman, Luke Shelton, who testified at the hearing on
18 December 13th. He is stating in his affidavit that he
19 reviewed the various override instruments creating
20 those -- documents creating the override interest and
21 that for each of the interests, that he did not feel it
22 authorized compulsory pooling. He has provided notice
23 to the overriding royalty interest owner.

24 Behind that, you will find an affidavit
25 from my office with an attached notice of the hearing

1 and returned green cards for all of those interests.

2 EXAMINER JONES: When did he provide the
3 notice?

4 MS. KESSLER: The notice was provided -- it
5 was the day after the hearing, so it was December 14.
6 And that letter should be included. This is Exhibit 27.
7 The letter is also included as Exhibit 26 in the prior
8 set of documents.

9 EXAMINER JONES: So there is an Exhibit 26?
10 Do we have an --

11 MS. KESSLER: That would be in the file
12 from the previous --

13 EXAMINER BROOKS: Yeah. They're not in
14 this pocket.

15 MS. KESSLER: So this is just the green
16 cards.

17 EXAMINER JONES: Okay. Any objection to
18 admitting to Exhibit 27.

19 MR. HALL: Not at all.
