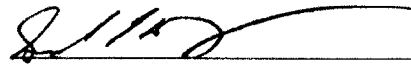
Sam Pryor, being first duly sworn on oath, states as follows:

1. My name is Sam Pryor and I am employed by MRC Energy Company, an affiliate of Matador Production Company ("Matador"), in Dallas, Texas, as Manager of Federal Lands. I previously testified as an expert in petroleum land matters in Case No. 15748 that resulted in the issuance of pooling Order R-14433 on September 1, 2017.
2. Division Order R-14433 created a 155.83-acre spacing and proration unit consisting of the S/2 S/2 of Section 19, Township 20 South, Range 29 East, NMPM, in Eddy County, New Mexico and pooled the uncommitted interests in the Bone Spring formation. This unit was to be initially dedicated to Matador's proposed **Stebbins 19 Federal Com No. 134H** (API No. 30-015-44187), a horizontal well to be drilled from a surface location 390 feet from the South line and 130 feet from the East line (Unit P) to a bottom hole location 330 feet from the South line and 240 feet from the West line (Lot 4, Unit M) of Section 19, Township 20 South, Range 29 East, NMPM.
3. Matador has now proposed to all of the interest owners to change the surface location and target of the initial well within the Bone Spring formation. The revised surface location is 180 feet from the South line, 110 feet from the East line (Unit P) to a standard bottom hole location 330 feet from the South line, 240 feet from the West line (Unit M) of Section 19, Township 20 South, Range 29 East, NMPM, in Eddy County, New Mexico. The well will target the Second Bone Spring.
4. In addition, Matador has changed the name of the proposed well from Stebbins 19 Federal Com No. 134H to the **Stebbins 19 Federal Com No. 124H** (API No. 30-015-44172).

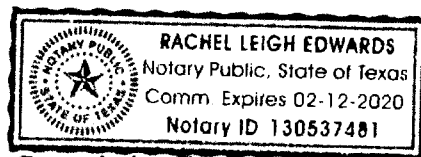

MRC Delaware Resources, LLC and its operating company Matador Production Company (collectively "MRC") propose the drilling of the Stebbins 19 Fed #124H well (the "Well"), located in the S/2S/2 of Section 19, Township 20 South, Range 29 East, Eddy County, New Mexico, to test the 2nd Bone Spring formation. The estimated cost of drilling, testing, completing, and equipping the Well is \$7,132,865, as itemized on the enclosed Authority for Expenditure ("AFE") dated November 28, 2017.

The Well will be drilled to a total vertical depth of 7,710' and a total measured depth of 12,336', producing a treatable lateral of approximately 4,629' within the 2nd Bone Spring formation.

MRC is proposing to drill the Well under the terms of the modified 1989 AAPL form of Operating Agreement ("OA") dated April 10, 2017. The Operating Agreement covers the S/2 of Section 19, Township 20 South, Range 29 East, limited to those formations from a depth of 200' beneath the surface down to the top of the Strawn formation ("Contract Area") pursuant to the following terms:

- 100/300/300% Non-consent penalty
- \$7,000/\$700 Drilling and Producing overhead rate

MRC requests that you indicate your election to participate in the drilling and completion of the Well in the space provided below, sign and return one (1) copy of this letter along with your geological well requirements, the AFE, and the OA to the undersigned.

If your election is to participate in the drilling and completion of the Well, please sign and return a copy of the enclosed AFE within thirty (30) days of receipt of this notice. Please be aware that the enclosed AFE is only an estimate of costs to be incurred and by electing to participate in the Well, each working interest owner shall be responsible for its proportionate share of all costs incurred.
