2 EXAMINER GOETZE: Good morning, ladies and  
3 gentlemen. This is the New Mexico Oil Conservation  
4 Division Examiner Hearing, Docket Number 5-18. Today is  
5 Thursday, February 8th, 2018. We're in Porter Hall. I  
6 am your examiner for today. My name is Phillip Goetze.  
7 And to my right is legal counsel, Mr. David Brooks.

8 The first item of business, a quick notice  
9 for those folks preparing applications and notices.  
10 We've been noticing a trend in the applications coming  
11 in that the notices that go out on the docket are not  
12 showing the same information. Florene's world has

5 continued to February 22nd.

6 This goes from page 4 into page 5: Cases  
7 Number 15913, 15914 and 15968 have been consolidated for  
8 a special docket set for February 27th.

9 Page 6, Case Number 15969 has been  
10 continued to February 22nd. Case Number 15971 has been  
11 continued to February 22nd.

12 Page 8, Case Number 15978 has been  
13 continued to March 8th.

14 And then page 10, Case Number 15926 has  
15 been continued to February 22nd.
