Hello Michael,

These cases were heard April 5th and were uncontested.

I am writing to see if OXY wants to dismiss these two cases and bring one case covering the W/2 for drilling the three planned Bone Spring wells.

Reasoning as follows:

The NWNW of Section 26 was an unleased federal tract.

At the hearing, the Landman for OXY said that Matador picked up the tract at the sale and OXY was working with Matador.

The application in Case 16058 asked for An Alternative spacing unit but at the hearing the testimony was that it was no longer needed because Matador picked up the NWNW and OXY would be signing or pooling Matador.

But that made the acreage in the W/2 diversely owned (W2W2 now differs from E2W2).

In Case 15059 which case covers the E2W2, the well that is planned near the west side of that spacing unit is at a non-standard location and needs an exception.

Leonard has informed me that Matador protested the proposed NSL for the Corral Fly 35 26 Federal Com Well No. 22H (30-015-44703) about 3 weeks ago and he canceled the application.

I will hold out on releasing these until you let me know,
