Gentlemen:

The initial Bone Spring Formation Participating Area "N" is hereby approved effective as of November 3, 2014, pursuant to Section 11 of the Poker Lake Unit Agreement, Eddy County, New Mexico. This participating area has been designated NMNM71016V.

The application establishes an initial Bone Spring Formation Participating Area "N" of 557.08 acres and is based upon the completion of unit well CVX JV BS 27H, located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$  (SHL) of Section 3, T.25S., R.31E., unit tract No. 22A, Lease No. NMNM030457, and in the NE $\frac{1}{4}$ SW $\frac{1}{4}$  (BHL) of Section 27, T.24S., R.31E., unit tract No. 3A, Lease No. NMNM0522A, with an initial potential of 487 BOPD and 1,113 MCFPD on November 3, 2014, from the Bone Spring Formation.


The application is also based upon the completion of unit well CVX JV BS 30H, located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$  (SHL) of Section 3, T.25S., R.31E., unit tract No. 22A, Lease No. NMNM030457, and in the SE $\frac{1}{4}$ SW $\frac{1}{4}$  (BHL) of Section 10, T.25S., R.31E., unit tract No. 25B, Lease No. NMNM031384, with an initial potential of 649 BOPD and 1,152 MCFPD on November 16, 2014, from the Bone Spring Formation.

Copies of the approved request are being distributed to the appropriate agencies and one copy of Exhibits "A" and "B" are returned herewith. Please advise all interested parties of the approval of the initial Bone Spring Formation Participating Area "N" effective as of November 3, 2014.

Any production royalties that are due must be reported and paid within 30 days of the Bureau of Land Management's approval date or the payors will be assessed interest for late payment under the Federal Oil and Gas Royalty Management Act of 1982 (30 CFR 218.54). 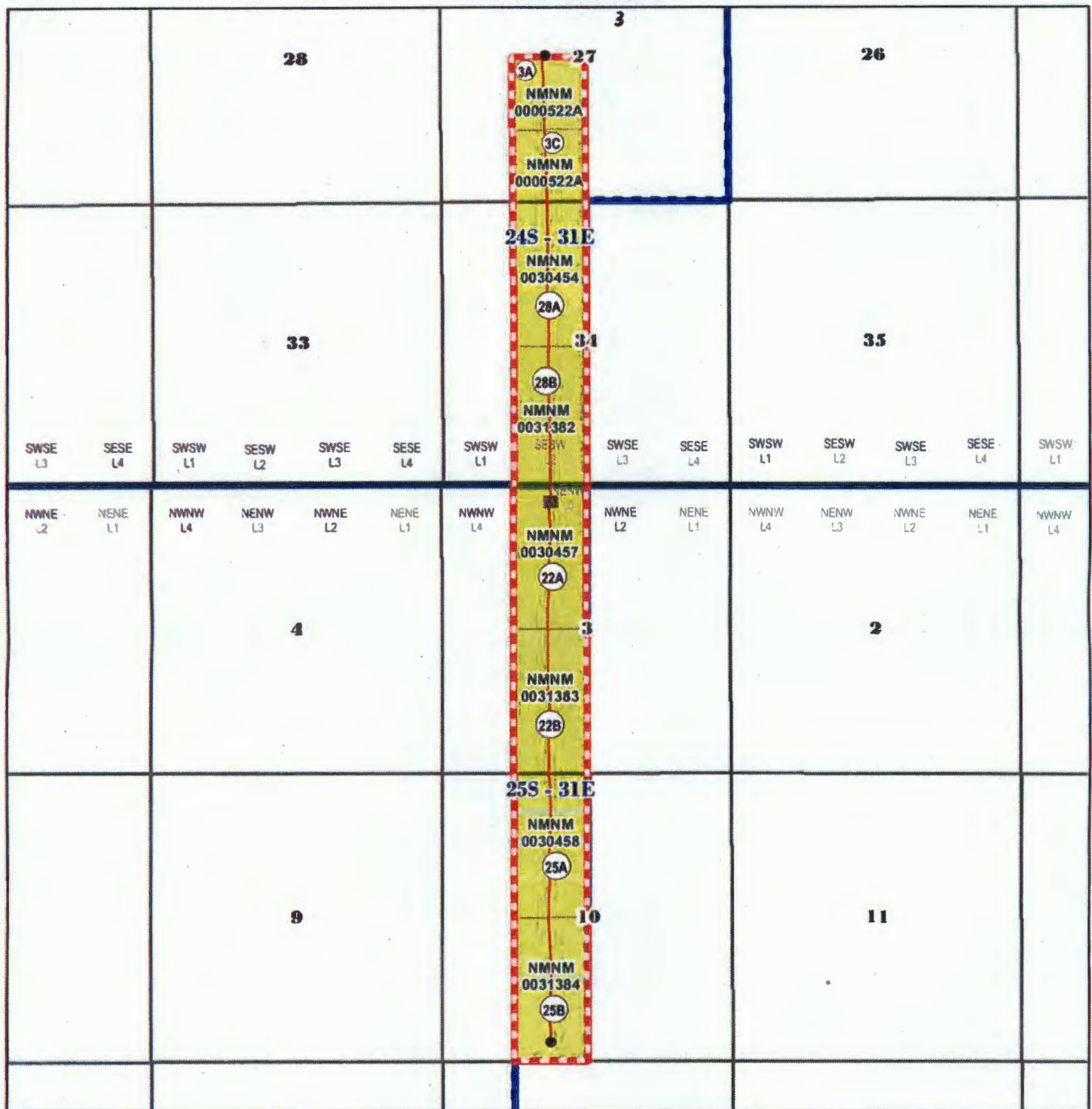
