MOTION FOR CONTINUANCE

Devon Energy Production Company, L.P., requests a continuance of the above cases currently set for hearing on August 9, 2018, and in support thereof states:

1. **Case No. 16164.** Devon Energy Production Company ("Devon") seeks approval of a 640-acre non-standard spacing and proration unit in the Purple Sage Wolfcamp Gas Pool (98220) comprised of the W/2 of Section 30 and the W/2 of Section 31, Township 23 South, Range 29 East, Eddy County, New Mexico. Devon further seeks the pooling of all mineral interests in the Purple Sage Wolfcamp Gas Pool underlying the proposed unit.

2. **Case No. 16165.** Devon Energy Production Company ("Devon") seeks approval of a 640-acre non-standard spacing and proration unit in the Purple Sage Wolfcamp Gas Pool (98220) comprised of the E/2 of Section 30 and the E/2 of Section 31, Township 23 South, Range 29 East, Eddy County, New Mexico. Devon further seeks the pooling of all mineral interests in the Purple Sage Wolfcamp Gas Pool underlying the proposed unit.

3. Kaiser-Francis Oil Company has filed applications in competing Case Nos. 16310 and 16311 covering a portion of the same lands as in Devon's Case Nos. 16163 and 16164.

4. Kaiser-Francis Oil Company does not oppose this motion. Devon has sought the agreement of MRC Permian Company and MRC Permian LKE Company to continue these cases; however, Devon has not yet received a response to its request.

WHEREFORE, Devon requests that Case Nos. 16346, 16347, 16348 and 16349 be continued to the September 6, 2018 hearing.
