

Your application of April 1, 2017, filed with the Bureau of Land Management (BLM) Carlsbad Field Office (CFO), requests the designation of the **Zia Hills BS/WC Unit Area**, embracing **13,543.35 acres**, more or less, in Lea and Eddy Counties, New Mexico, as logically subject to exploration and development under the unitization provisions of the Mineral Leasing Act, as amended.

Pursuant to public interest requirements and unit plan regulations 43 CFR 3180, the land requested, as outlined on your plat marked Exhibit "A" and Exhibit "B", the Zia Hills BS/WC Unit Area, Lea and Eddy Counties, New Mexico, is hereby designated as a logical unit area and has been assigned agreement number **NMNM 138329X**. This unit designation is for all oil and gas from the **Bone Spring and Wolfcamp formations only** and is valid for a period of one year from the date of this letter.

The unit agreement submitted for the area designated will provide for the drilling of three (3) obligation wells to test the Wolfcamp formation with two (2) one-mile horizontal wells and to test the Bone Spring formation with one (1) one-mile horizontal well in the following locations:

Surface location: Section 19-T26S-R32E
Bottom hole location: Section 7-T26S-R32E
Formation: Wolfcamp

Surface location: Section 20-T26S-R32E
Bottom hole location: Section 32-T26S-R32E
Formation: Wolfcamp

Surface location: Section 25-T26S-R32E
Bottom hole location: Section 36-T26S-R32E

Formation: Bone Spring

As stated in Section 3 in the unit agreement unitized substances are as follows:

"All oil and gas in any and all formations of the unitized land below the base of the Brushy Canyon formation at a measured depth of 7,678 feet down to the stratigraphic equivalent of to the top of the Cisco formation at a measured depth of 14,050 feet as encountered in the Stampede 27 1M (API #30-015-42118) and State 'GR' 1 (API #30-025-26785) are unitized under the terms of this agreement and herein are called "unitized substances."

After completion of the obligation wells in their respective formations, and upon application by the unit operator with sufficient technical justification that satisfies the AO, one participating area shall be established for the Wolfcamp formation encompassing all lands within the unit area and one participating area shall be established for the Bone Spring formation encompassing all lands within the unit area. These participating areas shall be subject to the development provisions of Section 10 and the expansion and exclusion provisions of Section 11 of the Unit Agreement.

Any producible wells that exist in the unit area prior to unitization will not be recognized as unit wells until after establishment of an initial participating area based on the aforementioned obligation wells.

Your proposed use of the Form of Agreement for Unproven Areas at 43 CFR 3186.1, modified only as shown in your application and enclosed with this letter, will be accepted. It is recognized that modifications to include State of New Mexico Lands and references to the Land Commissioner in the language of this agreement have been submitted voluntarily by ConocoPhillips and that such language shall not adversely affect Federal lands or limit or alter the jurisdiction and responsibilities of the BLM Authorized Officer established by the Mineral Leasing Act of 1920, as amended, and regulations promulgated at 43 CFR 3180.

If conditions are such that further modification of said standard form is deemed necessary, two copies of the proposed modifications with appropriate justification must be re-submitted to this office for preliminary approval. In the absence of any type of land requiring special provisions or of any objections not now apparent, a duly executed agreement identical with said form, modified as outlined above, will be approved if submitted in approvable status within a reasonable period of time. However, notice is hereby given that the right is reserved to deny approval of any executed agreement submitted that, in our opinion, does not serve the public interest or does not have the full commitment of sufficient lands to afford effective control of operations in the unit area.

Please include a separate recapitulation of the latest commitment status of the interests in each tract when the executed agreement is submitted for final approval.

In preparing Exhibits "A" and "B", the format of the sample exhibits of the model form shall be followed. A minimum of three copies of the executed agreement shall be submitted with your request for final approval.

Inasmuch as this unit area contains State of New Mexico lands, the unit operator must receive approval of this unit agreement from the New Mexico State Land Office before submitting to BLM for final approval.

As provided in 43 CFR 3165.3(b), you may request an administrative review of this decision before the State Director. Per 43 CFR 3165.4, you may appeal any instructions, orders, or decisions issued by the BLM New Mexico State Office directly to the Interior Board of Land Appeals pursuant to the regulations found at 43 CFR 4. A copy of Form 1842-1, *Information on Taking Appeals to the Interior Board of Land Appeals*, is enclosed.

The following outlines the status of the Zia Hills BS/WC Unit Agreement in terms of preliminary approval from the New Mexico State Land Office:

- ConocoPhillips received preliminary approval on April 13, 2017. At that time, the proposed unit consisted of 13,085.23 federal acres and 778.12 State Trust acres, totaling 13,863.35 acres. The State Trust percentage in the unit would be 5.6%.
- ConocoPhillips requested and received confirmation of preliminary approval on June 1, 2018, after the State Land Office ensured that the language contained in the unit agreement included dual authority of BLM and State Land Commissioner for approval of unit agreement requirements.
- Subsequently, BLM informed ConocoPhillips that 320 acres of the original 13,863.35 federal acres that would have been dedicated to the unit were currently unleased. After conferring with ConocoPhillips, BLM made the decision to designate the unleased 320 acres as uncommitted to the unit. The proposed unit would then consist of 12,765.23 federal acres and 778.12 State Trust acres, totaling 13,543.35 acres. The State Trust percentage in the unit would be 5.7%.

The New Mexico State Land Office reconfirms on this date (August 8, 2018) its preliminary approval for the Zia Hills BS/WC Unit. The exclusion of the 320 federal acres increases the State Trust percentage in the unit to 5.7%, thus continuing to meet the requirement that forming the unit is in the best interests of the State Trust beneficiaries. Should the currently unleased 320 federal acres become leased at a future date and be considered for inclusion in the unit, such

Dear Mr. Travers:

This office has received the unexecuted copy of the unit agreement that you have submitted for the proposed Zia Hills Unit area, Eddy and Lea Counties, New Mexico. This agreement meets the general requirements of the Commissioner of Public Lands, who has this date granted you preliminary approval as to form and content.

Preliminary approval shall not be construed to mean final approval of this agreement in any way and will not extend any short-term leases until final approval and an effective date have been given.

When submitting your agreement for final approval, please include the following:

1. Application for final approval by the Commissioner setting forth the tracts that have been committed and the tracts that have not been committed.
2. Pursuant to Rule 19.2.100.51, a statement of facts showing that:
 - a. The agreement will tend to promote the conservation of oil and gas and the better utilization of reservoir energy.
 - b. Under the proposed unit operation, the State of New Mexico will receive its fair and equitable share of the recoverable oil and gas in place under its lands in the proposed unit area.
 - c. Each beneficiary institution of the State of New Mexico will receive its fair and equitable share of the recoverable oil and gas under its lands within the unit area.
 - d. The unit agreement is in other respects for the best interest of the Trust.

3. All ratifications from the Lessees of Record and Working Interest Owners. All signatures should be acknowledged by a notary and one set must contain original signatures.
4. Approval order from the New Mexico Oil Conservation Division. State Land Office approval is conditioned upon approval by the New Mexico Oil Conservation Division.
5. Approval order from the Bureau of Land Management. State Land Office approval is conditioned upon approval by the Bureau of Land Management.
6. One copy of the Unit Operating Agreement (if applicable).
7. A \$2,800 filing fee. The filing fee is \$100 for each section or partial section included in the unit, whether federal, state, or privately owned.
