STATEMENT OF THE CASE

Case No. 16449: Devon Energy Production Company ("Devon") seeks an order pooling all uncommitted mineral interests in the Bone Spring formation underlying the E/2W/2 and W/2E/2 of Sections 30 and 31, Township 23 South, Range 29 East, Eddy County, New Mexico. Devon proposes to dedicate the above-referenced 640.00 acre spacing and proration unit as the standard horizontal spacing and proration unit for the **Spud Muffin 31-30 332H well** to be horizontally drilled in the **Cedar Canyon; Bone Spring (Pool Code 11520)** from a surface

location 625' FSL and 2405' FWL of Section 31 to a bottom hole location of 20' FNL and 2549' FWL of Section 30.

The well in this case and the wells proposed in Case Nos. 16163, 16164, 16346 and 16349 will be pad-drilled sequentially and batch completed. The completed intervals for all wells will be orthodox.
