Chase Rice, being duly sworn, deposes and states:

1. I am over the age of 18, I am the landman for Marathon Oil Permian LLC and have personal knowledge of the matters stated herein. I have been qualified by the Oil Conservation Division ("Division") as an expert petroleum landman.

2. I submit the following information pursuant to NMAC 19.15.4.12.A(1) in support of the above referenced compulsory pooling application.

3. The purpose of this application is to add an additional well to Order R-14623 that pooled the interest owners in the horizontal spacing units described below.

4. No opposition is expected because the interest owners have been contacted regarding the proposed additional wells, but have failed or refused to voluntarily commit their interests in the wells.

5. Case No. 15958 (re-opened):

a. Marathon seeks an order amending Order R-14623 to 1) add additional wells and to 2) allow for additional time to complete the wells.

b. Marathon obtained Order R-14623 in order to facilitate the drilling and completion of the Sweet Tea State 24-29-31 WA No. 5H and the Sweet Tea State 24-29-31 WXY Well No. 3H wells, which are horizontal wells that will develop the Wolfcamp formation underlying the W/2 of Section 6, Township 25 South, Range 29 East, and SW/4 of Section 31, Township 24 South, Range 29 East, NMPM, Eddy County, New Mexico to the proposed well to form a non-standard 480-acre oil spacing and proration unit.

c. Marathon seeks to drill the **Sweet Tea State 24 29 31 WD 2H** well within the spacing unit approved by the Division.

d. A plat outlining the unit pooled by Order R-14623 is attached hereto as **Exhibit A**, which shows the proposed well's location within the unit. The parties that were pooled, and percent of their interests are also included as part of **Exhibit A**. The parties' addresses are identified in the affidavit of notice, Exhibit 3.

e. There are no depth severances within the Wolfcamp formation.

f. I have conducted a diligent search of the public records in the county where the well is located, and conducted phone directory and computer searches to locate contact information for parties entitled to notification, and mailed all parties well proposals, including an Authorization for Expenditure.

g. Marathon has made a good faith effort to obtain voluntary joinder of the working interest owners in the proposed well. A summary of my attempts to contact working interest owners is attached as **Exhibit B**.

h. Attached as **Exhibit C** is the proposed C-102 for the well. The well will develop the Wolfcamp formation, Purple Sage; Wolfcamp (Gas) Pool, pool code 98220.

i. The producing interval for the well will be orthodox and will comply with the Division's set back requirements.

j. **Exhibits D and E** are a sample proposal letter and the Authorization for Expenditure for the proposed well. The estimated cost of the well set forth therein is fair and reasonable, and is comparable to the costs of other wells of similar depths and length drilled in this area of New Mexico.

6. Marathon requests overhead and administrative rates of \$7000/month for drilling a well and \$700/month for a producing well. These rates are fair, and comparable to the rates charged by other operators for wells of this type in this area of Southeastern, New Mexico. Marathon requests that these rates be adjusted periodically as provided in the COPAS Accounting Procedure.

7. Marathon requests the maximum cost plus 200% risk charge be assessed against non-consenting working interest owners.

8. Marathon requests that it be the designated operator of the well.

9. Under the order, the Division requires Marathon to complete specified wells within 120 days after the wells are drilled. Due to the rising demand for completion crews in this area, Marathon requests an extension of one (1) year between the time when the well is drilled and the completion of the well.

10. The attachments to this affidavit were prepared by me, or compiled from company business records.

11. I attest that the information provided herein is correct and complete to the best of my knowledge and belief.

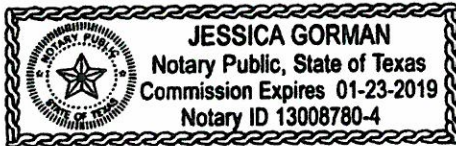

Marathon Oil Permian LLC ("MRO"), as operator, proposes the drilling and completion of the following wells located in the SW/4 of Section 31 T24S-R29E and the W/2 of Section 6, T25S-R29E, Eddy County, New Mexico all to be drilled from the same surface pad location.

- Sweet Tea State 24 29 31 WD 2H with a proposed first take point located approximately 330' FWL and 2,310' FSL of Section 31, 24S-29E, and a proposed last take point located 330' FWL and 330' FSL of Section 6, 25S-29E. The well will have a targeted interval located in the Wolfcamp Formation (~10,517' TVD) with a productive lateral length of approximately 7,320'. The total estimated drilling and completion costs are reflected on the attached AFE document.
- Sweet Tea State 24 29 31 SB 4H with a proposed first take point located approximately 663' FWL and 2,340' FSL of Section 31, 24S-29E, and a proposed last take point located 654' FWL and 330' FSL of Section 6, 25S-29E. The well will have a targeted interval located in the Bone Spring Formation (~8,382' TVD) with a productive lateral length of approximately 7,315'. The total estimated drilling and completion costs are reflected on the attached AFE document.

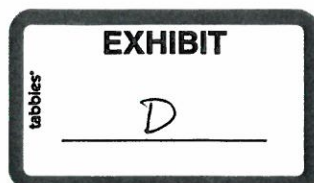
These proposed locations and target depths are subject to change depending on any surface or subsurface concerns encountered. The AFEs represent an estimate of the costs that will be incurred to drill and complete the wells, but those electing to participate in the wells are responsible for their proportionate share of the actual costs incurred.

A Joint Operating Agreement is currently going through final review and will be circulated to the Working Interest Owners for execution, as well as a Communization Agreement.

Matt Baker, being duly sworn, deposes and states:

1. I am over the age of 18, I am a geologist for Marathon Oil Permian LLC and have personal knowledge of the matters stated herein. I have been qualified by the Oil Conservation Division ("Division") as an expert petroleum geologist.

2. **Exhibit A** is a structure map of the top of the Wolfcamp. The proposed project area is identified by black-dashed boxes. The proposed horizontal locations are identified by a blue line, and the proposed Wolfcamp well is identified as **Sweet Tea State 24 29 31 WD 2H**.

3. Exhibit A identifies Wolfcamp wells in the vicinity of the proposed well, with a line of cross-section running from A to A'.

4. Exhibit A shows that the structure dips down to the East.

5. **Exhibit B** is a Wolfcamp cross section. It is a stratigraphic cross-section hung on the top of the Wolfcamp formation. The well logs on the cross-section give a representative sample of the Wolfcamp formation in the area. The target zone for the **Sweet Tea State 24 29 31 WD 2H**

well is the Wolfcamp C2 and D2 formations, as identified by the words "Producing Zone" and the shaded area across the cross section. That zone is relatively continuous across the well unit.

6. **Exhibit C** is a Gross Interval Isochore of the Wolfcamp C2 to Wolfcamp D2 marker. The Wolfcamp C2 to Wolfcamp D2 interval is relatively uniform across the proposed well unit.

7. I conclude from the maps that:

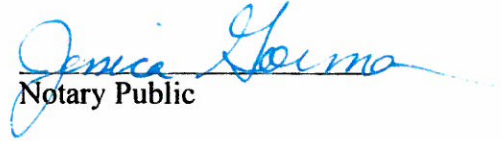
- a. The horizontal spacing unit is justified from a geologic standpoint.
- b. There are no structural impediments of faulting that will interfere with horizontal development.
- c. Each quarter quarter section in the unit will contribute more or less equally to production.

8. The preferred well orientation in this area is north-south. This is because the maximum horizontal stress orientation is roughly east-west.

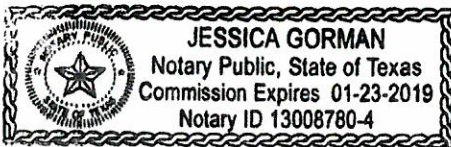

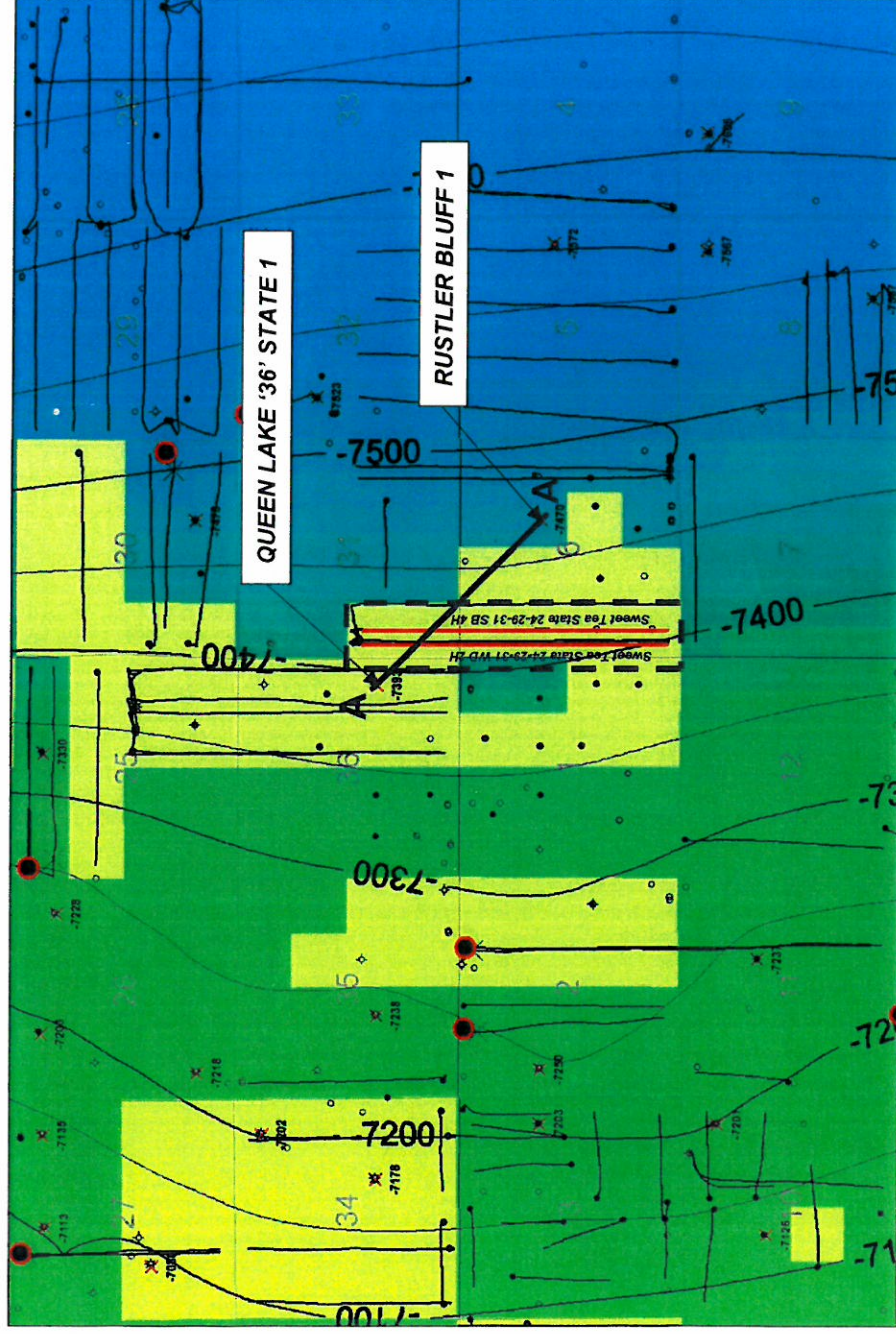

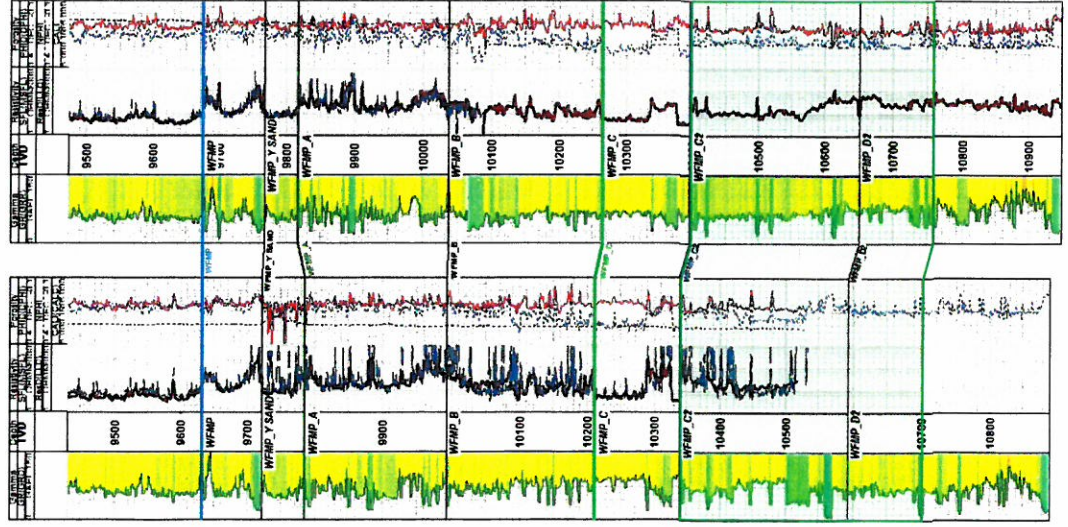

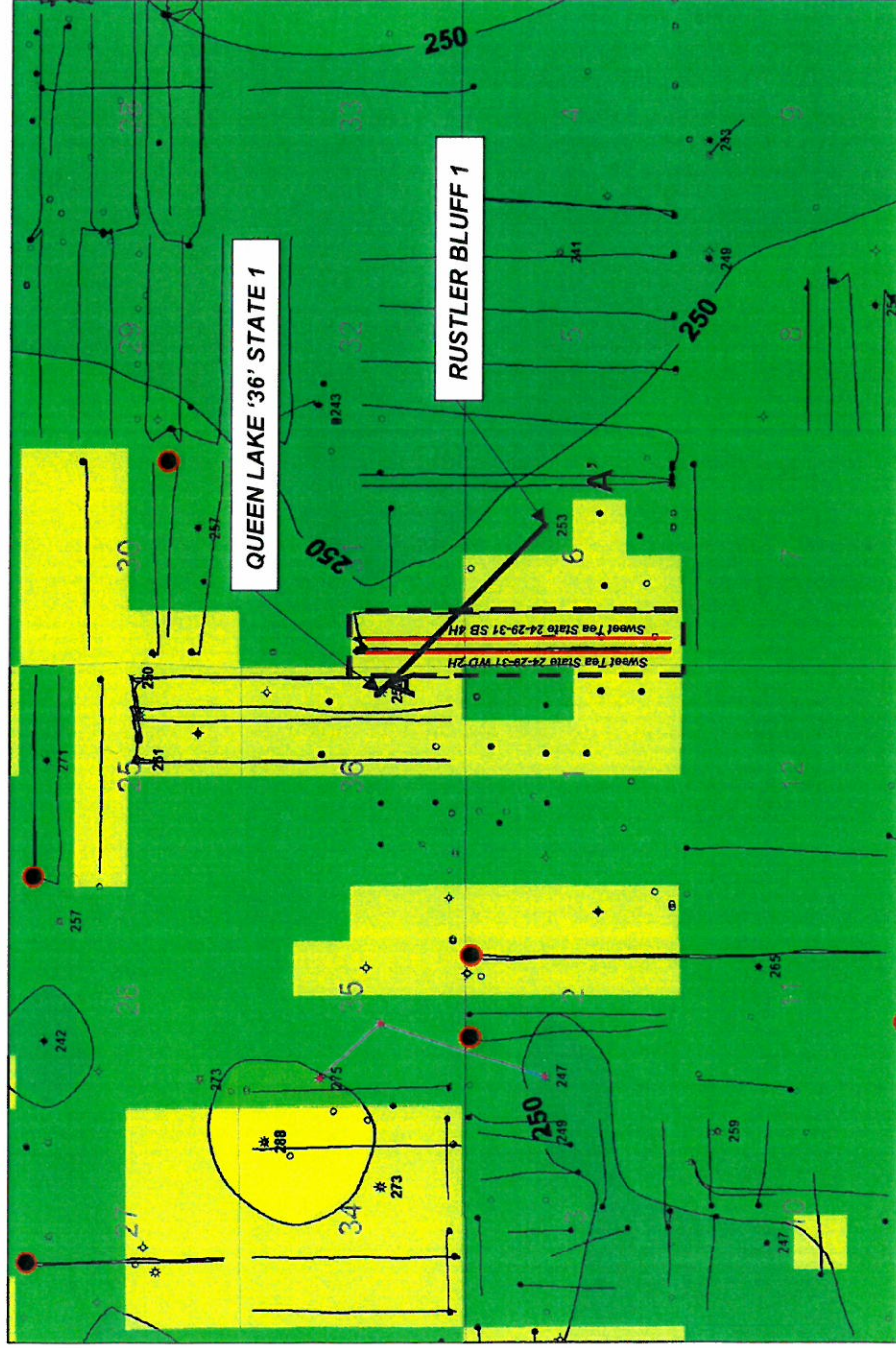
