This letter is to advise you that Delaware Energy, LLC has filed the above-styled application with the New Mexico Oil Conservation Division. Applicant seeks an order authorizing injection of produced water for disposal purposes through its proposed **Giant Panda SWD #1**, with an amended surface location 1440 feet from the South line and 560 feet from the West line Unit L of Section 16, Township 24 South, Range 27 East, NMPM, Eddy County, New Mexico. The maximum proposed daily injection rate will be approximately 25,000 barrels per day. The proposed injection will occur within the Devonian formation at a depth of approximately 13,255 feet to 14,255 feet deep. The maximum injection pressure will be 2,651 psi. The location of the proposed injection is approximately 4 miles southwest of Malaga, New Mexico. As an affected party, you are entitled to notice of this application.

This application has been set for hearing before a Division Examiner at 8:15 AM on February 21, 2019, and the status of the hearing can be monitored through the Division's website at <http://www.emnrd.state.nm.us/ocd/>. The hearing will be held in Porter Hall in the Oil Conservation Division's Santa Fe Offices located at 1220 South Saint Francis Drive, Santa Fe, New Mexico 87505. You are not required to attend this hearing, but as an owner of an interest that may be affected by this application, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.

Parties appearing in cases are required by Division Rule 19.15.4.13.B to file a Pre-Hearing Statement with the Oil Conservation Division's Santa Fe office, four days in advance of a scheduled hearing, but at least on the Thursday preceding the hearing. This statement must include: the names of the parties and their attorneys; a concise statement of the case; the names of all witnesses the party will call to testify at the hearing; the approximate time the party will need to present its case; and identification of any procedural matters that are to be resolved prior to the hearing.


