STATEMENT OF THE CASE

APPLICANT

Mewbourne Oil Company seeks an order pooling of all mineral interests in the Bone Spring formation underlying a 160-acre horizontal spacing unit comprised of the E/2W/2 of Section 22, Township 23 South, Range 34 East, NMPM. The unit will be dedicated to (a) the Gazelle 22 B3NC Fed. Com. Well No. 1H, a horizontal well with a first take point in the SE/4SW/4 and a final take point in the NE/4NW/4 of Section 22, and (b) the Gazelle 22 B2NC Fed. Com. Well No. 2H, a horizontal well with a first take point in the SE/4SW/4 and a final take point in the NE/4NW/4 of Section 22. Also to be considered will be the cost of drilling and completing the wells and the allocation of the cost thereof, as well as actual operating costs and charges for

supervision, designation of applicant as operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.


