MEWBOURNE OIL COMPANY'S RESPONSE TO MOTION FOR CONTINUANCE

Mewbourne Oil Company ("Mewbourne") files this response to the motion for a continuance filed by Percussion Petroleum Operating, LLC ("Percussion").

- 1. Mewbourne and Percussion have filed competing applications seeking to pool the Glorieta-Yeso formation in a horizontal spacing unit comprised of the E/2E/2 of Section 34, Township 19 South, Range 25 East, NMPM.
- 2. Percussion has filed a motion for a continuance seeking a special hearing date. Apparently Mewbourne had agreed to a special date a month ago (the undersigned's memory is apparently failing). However, no special date was ever set, so Mewbourne opposed a continuation from the March 21st docket.
- 3. Percussion spends time in its motion, without any evidentiary development, requesting a continuance due to alleged better development plans and lack of good faith negotiations. These statements are superfluous. All Percussion needed to say was the statement

in Paragraph 9 of the motion: It has witness availability problems. As a result, Mewbourne accedes to the continuance request.

4. However, absent a setting for a special hearing, Mewbourne requests that these cases be heard on April 18th.

WHEREFORE, Mewbourne requests that Percussion's motion be granted, but the case be set for hearing on April 18th.
