STATEMENT OF THE CASE

The well density requirements in the Special Rules and Regulations of the Blanco-

Mesaverde Gas Pool currently state as follows:

I. ACREAGE AND WELL LOCATION REQUIREMENTS

A. Standard GPU (Gas Proration Unit): A standard GPU in the Blanco-Mesaverde Pool shall be 320 acres (more or less) comprising any two contiguous quarter sections of a single section that is a legal subdivision of the U. S. Public Land Surveys.

B. Well density:

- (1) Up to four (4) wells may be drilled on a standard GPU, as follows:
 - (a) the FIRST OPTIONAL INFILL WELL drilled on a GPU shall be located in the quarter section not containing the INITIAL Mesaverde well;
 - (b) the SECOND OPTIONAL INFILL WELL drilled on a GPU shall be located in a quarter-quarter section not containing a Mesaverde well and within a quarter section not containing more than one (1) Mesaverde well;
 - (c) the THIRD OPTIONAL INFILL WELL drilled on a GPU shall be located in a quarter-quarter section not containing a Mesaverde well and within a quarter section not containing more than one (1) Mesaverde well;
 - (d) at the discretion of the operator, the second or third optional infill well may be drilled prior to the drilling of the first optional infill well;
 - (e) no more than two wells shall be located within either quarter section in a GPU; and
 - (f) any deviation from the above-described well density requirements shall be authorized only after hearing.

In these sixteen consolidated cases, Hilcorp seeks approval under Rule I(B)(1)(f) for the

Division to enter an order granting an exception to the well density requirements as follows:

- In Case No. 20348, Hilcorp requests that the Division enter an order granting an exception to authorize Hilcorp to simultaneously dedicate and produce the Hardie 5E Well (API No. 30-045-24935) in Unit A of the E/2 of Section 23, Township 28 North, Range 8 West, permitting the total number of wells dedicated and producing within this spacing and proration unit to five, with three wells in the same quarter section.
- In Case No. 20349, Hilcorp requests that the Division enter an order granting an exception to authorize Hilcorp to simultaneously dedicate and produce the Davis A Federal 001 (API No. 30-045-09210) in Unit D/Lot 4 of the W/2 of Section 25, Township 30 North, Range 11 West, permitting the total number of wells dedicated and producing within this spacing and proration unit to five, with three wells in the same quarter section.
- In Case No. 20350, Hilcorp requests that the Division enter an order granting an exception to authorize Hilcorp to simultaneously dedicate and produce the San Juan 27-5 Unit 126E Well (API No. 30-039-30518) with a surface location in Unit L and a bottom-hole location in Unit F of the W/2 of Section 7, Township 27 North, Range 5 West, permitting the total number of wells dedicated and producing within the same quarter section to three.
- In Case No. 20351, Hilcorp requests that the Division enter an order granting an exception to authorize Hilcorp to simultaneously dedicate and produce the San Juan 27-5 Unit 86 Well (API No. 30-039-07114) in Unit M of the W/2 of Section 9, Township 27 North, Range 5 West, permitting the total number of wells dedicated and producing within this spacing and proration unit to five, with three wells in the same quarter section and two wells within the same quarter-quarter section.
- In Case No 20352, Hilcorp requests that the Division enter an order granting an exception to authorize Hilcorp to simultaneously dedicate and produce the San Juan 28-6 Unit 111 Well (API No. 30-039-82368) in Unit M of the W/2 of Section 15, Township 27 North, Range 6 West, permitting the total number of wells dedicated and producing within this spacing and proration unit to five, with three wells in the same quarter section.
- In Case No. 20353, Hilcorp requests that the Division enter an order granting an exception to authorize Hilcorp to simultaneously dedicate and produce the San Juan 28-6 Unit 110 Well (API No. 30-039-82369) in Unit L of the W/2 of Section 25, Township 27 North, Range 6 West, permitting the total number of wells dedicated and producing within this spacing and proration unit to five, with three wells in the same quarter section.
- In Case No. 20354, Hilcorp requests that the Division enter an order granting an exception to authorize Hilcorp to simultaneously dedicate and produce the San Juan 28-6 Unit 169 Well (API No. 30-039-20477) in Unit M of the W/2 of

- Section 2, Township 27 North, Range 6 West, permitting the total number of wells dedicated and producing within this spacing and proration unit to five, with three wells in the same quarter section.
- In Case No. 20355, Hilcorp requests that the Division enter an order granting an exception to authorize Hilcorp to simultaneously dedicate and produce the San Juan 28-6 Unit 155 Well (API No. 30-039-20397) in Unit M of the W/2 of Section 28, Township 28 North, Range 6 West, permitting the total number of wells dedicated and producing within this spacing and proration unit to five, with three wells in the same quarter section.
- In Case No. 20356, Hilcorp requests that the Division enter an order granting an exception to authorize Hilcorp to simultaneously dedicate and produce the San Juan 28-6 Unit 186 Well (API No. 30-039-20582) in Unit H of the E/2 of Section 6, Township 27 North, Range 6 West, permitting the total number of wells dedicated and producing within this spacing and proration unit to five, with three wells in the same quarter section.
- In Case No. 20357, Hilcorp requests that the Division enter an order granting an exception to authorize Hilcorp to simultaneously dedicate and produce the San Juan 28-6 Unit 147 Well (API No. 30-039-20314) in Unit G of the E/2 of Section 29, Township 28 North, Range 6 West, permitting the total number of wells dedicated and producing within this spacing and proration unit to five, with three wells in the same quarter section.
- In Case No. 20358, Hilcorp requests that the Division enter an order granting an exception to authorize Hilcorp to simultaneously dedicate and produce the San Juan 28-7 Unit 246E Well (API No. 30-039-22360) in Unit N of the S/2 of Section 8, Township 28 North, Range 7 West, permitting the total number of wells dedicated and producing within this spacing and proration unit to five, with three wells in the same quarter section and two in the same quarter-quarter section.
- In Case No. 20359, Hilcorp requests that the Division enter an order granting an exception to authorize Hilcorp to simultaneously dedicate and produce the San Juan 28-7 Unit 220 Well (API No. 30-039-20865) in Unit N of the W/2 of Section 22, Township 28 North, Range 7 West, permitting the total number of wells dedicated and producing within this spacing and proration unit to five, with three wells in the same quarter section and two in the same quarter-quarter section.
- In Case No. 20360, Hilcorp requests that the Division enter an order granting an exception to authorize Hilcorp to simultaneously dedicate and produce the San Juan 28-7 Unit 136E Well (API No. 30-039-23752) in Unit N of the W/2 of Section 14, Township 28 North, Range 7 West, permitting the total number of

wells dedicated and producing within this spacing and proration unit to five, with three wells in the same quarter section.

- In Case No. 20361, Hilcorp requests that the Division enter an order granting an exception to authorize Hilcorp to simultaneously dedicate and produce the San Juan 28-7 Unit 218 Well (API No. 30-039-20879) in Unit N of the S/2 of Section 12, Township 28 North, Range 7 West, permitting the total number of wells dedicated and producing within this spacing and proration unit to five, with three wells in the same quarter section and two in the same quarter-quarter section.
- In Case No. 20362, Hilcorp requests that the Division enter an order granting an exception to authorize Hilcorp to simultaneously dedicate and produce the San Juan 29-6 Unit 75 Well (API No. 30-039-07579) in Unit H of the E/2 of Section 23, Township 29 North, Range 6 West, permitting the total number of wells dedicated and producing within this spacing and proration unit to five, with three wells in the same quarter section and two wells within the same quarter-quarter section.
- In Case No. 20363, Hilcorp requests that the Division enter an order granting an exception to authorize Hilcorp to simultaneously dedicate and produce the San Juan 29-7 Unit 117 Well (API No. 30-039-22762) in Unit L the W/2 of Section 19, Township 29 North, Range 7 West, permitting the total number of wells dedicated and producing within this spacing and proration unit to five, with three wells in the same quarter section.
