APPLICANT'S STATEMENT OF CASE

In Case No. 20365, Matador Production Company seeks an order pooling all uncommitted
interests in the Bone Spring formation in the 320-acre horizontal spacing unit comprised of the

W/2 W/2 of Sections 15 and 22, Township 26 South, Range 31 East, NMPM, Eddy County, New Mexico. The spacing unit will be dedicated to the proposed **Boros Fed Com 101H Well**, which will be horizontally drilled from a surface location in the NW/4 NW/4 (Unit D) of Section 15 to bottom hole location in the SW/4 SW/4 (Unit M) of Section 22, and the proposed **Boros Fed Com 121H Well**, which will be horizontally drilled from a surface location in the NW/4 NW/4 (Unit D) of Section 15 to bottom hole location in the in SW/4 SW/4 (Unit M) of Section 22. The completed interval for these wells will remain within the standard offset required by the statewide rules set forth in 19.15.15 NMAC.

In Case No. 20366, Matador Production Company seeks an order pooling all uncommitted interests in the Wolfcamp formation in the 640-acre horizontal spacing unit comprised of the W/2 of Sections 15 and 22, Township 26 South, Range 31 East, NMPM, Eddy County, New Mexico. The spacing unit will be dedicated to the following proposed wells:

- **Boros Fed Com 201H Well**, which will be horizontally drilled from a surface location in the NW/4 NW/4 (Unit D) of Section 15 to bottom hole location in the SW/4 SW/4 (Unit M) of Section 22.
- **Boros Fed Com 202H Well**, which will be horizontally drilled from a surface location in the NE/4 NW/4 (Unit C) of Section 15 to bottom hole location in the SE/4 SW/4 (Unit N) of Section 22.
- **Boros Fed Com 221H Well**, which will be horizontally drilled from a surface location in the NW/4 NW/4 (Unit D) of Section 15 to bottom hole location in the SW/4 SW/4 (Unit M) of Section 22.

- **Boros Fed Com 222H Well**, which will be horizontally drilled from a surface location in the NE/4 NW/4 (Unit C) of Section 15 to bottom hole location in the SE/4 SW/4 (Unit N) of Section 22.

The completed interval for each well will remain within the setbacks required by the Special Rules for the Purple Sage; Wolfcamp (Gas) (Pool Code 98220).
