The applications, prehearing statements and the Mitchell affidavit filed in these consolidated cases state the pool is the Red Lake Glorieta-Yeso Pool (51120). That is the pool to which we understand these wells will be assigned.

After further analysis following submission of the well proposal letters, Percussion has determined the better depths for these initial wells are 3,400 for Smashing Pumpkin well and 3,500 for Oasis well as reflected on the cross section submitted at the hearing.
