STATEMENT OF CASE

APPLICANT:

In Case No. 20573 Permian Oilfield Partners, LLC, seeks an order approving disposal into the Silurian-Devonian formation through the JDAM Federal SWD Well #1 well at a surface location 2027 feet from the South line and 250 feet from the East line of Section 23, Township 25 South, Range 33 East, NMPM, Lea County, New Mexico for the purpose of operating a produced water disposal well. Applicant seeks authority to inject produced water into the Silurian-Devonian formation at a depth of approximately 17,573' to 19,043'. Applicant further seeks approval of the use of 7 inch tubing inside the surface and intermediate casings and 5 ½ inch tubing inside the liner and requests that the Division approve a maximum daily injection rate for the well of 50,000 bbls per day. Said area is located approximately 20.0 miles West of Jal, New Mexico.
