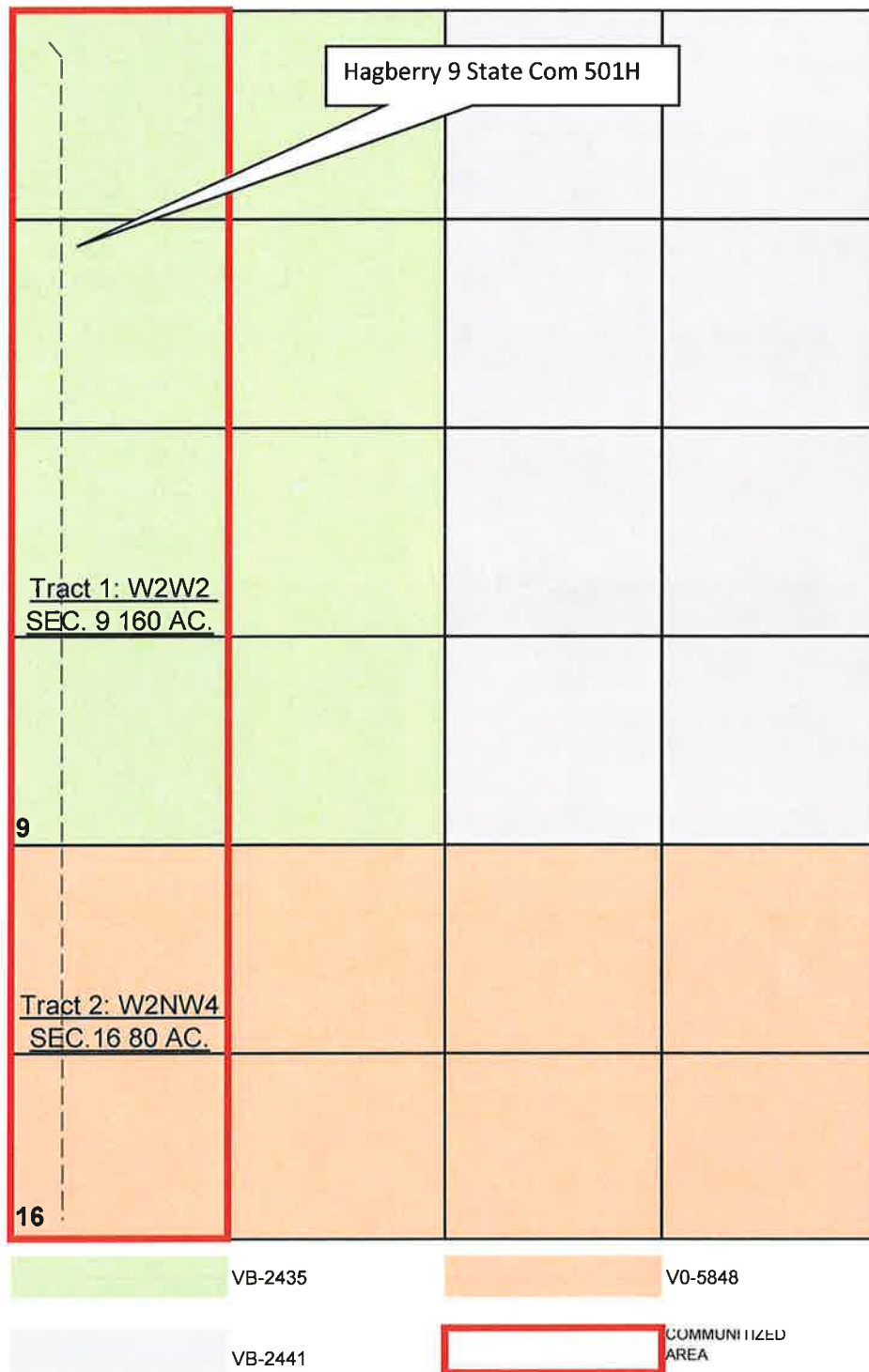

Centennial Resource Production, LLC ("CRP") proposes to drill and complete the Hagberry 9 State Com #501H as a horizontal well to test the Bone Spring Formation at a TVD of 10,359 feet. The W/2 W/2 of the referenced Section 9 and the W/2 NW/4 of Section 16 will be dedicated to the well as the proration unit being a total of 240 acres. Please see the enclosed AFE in the amount of \$10,692,605.00.

Upon your response we will send a Joint Operating Agreement ("JOA") with an effective date of April 1, 2019. The JOA contains a proposed overhead rate of \$7500 per day for drilling and \$750 per day for producing and provides for a 100%/300%/300% non-consent penalty.

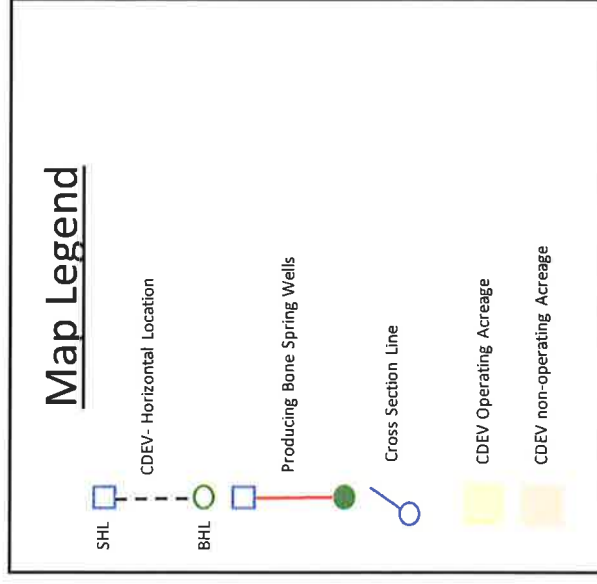
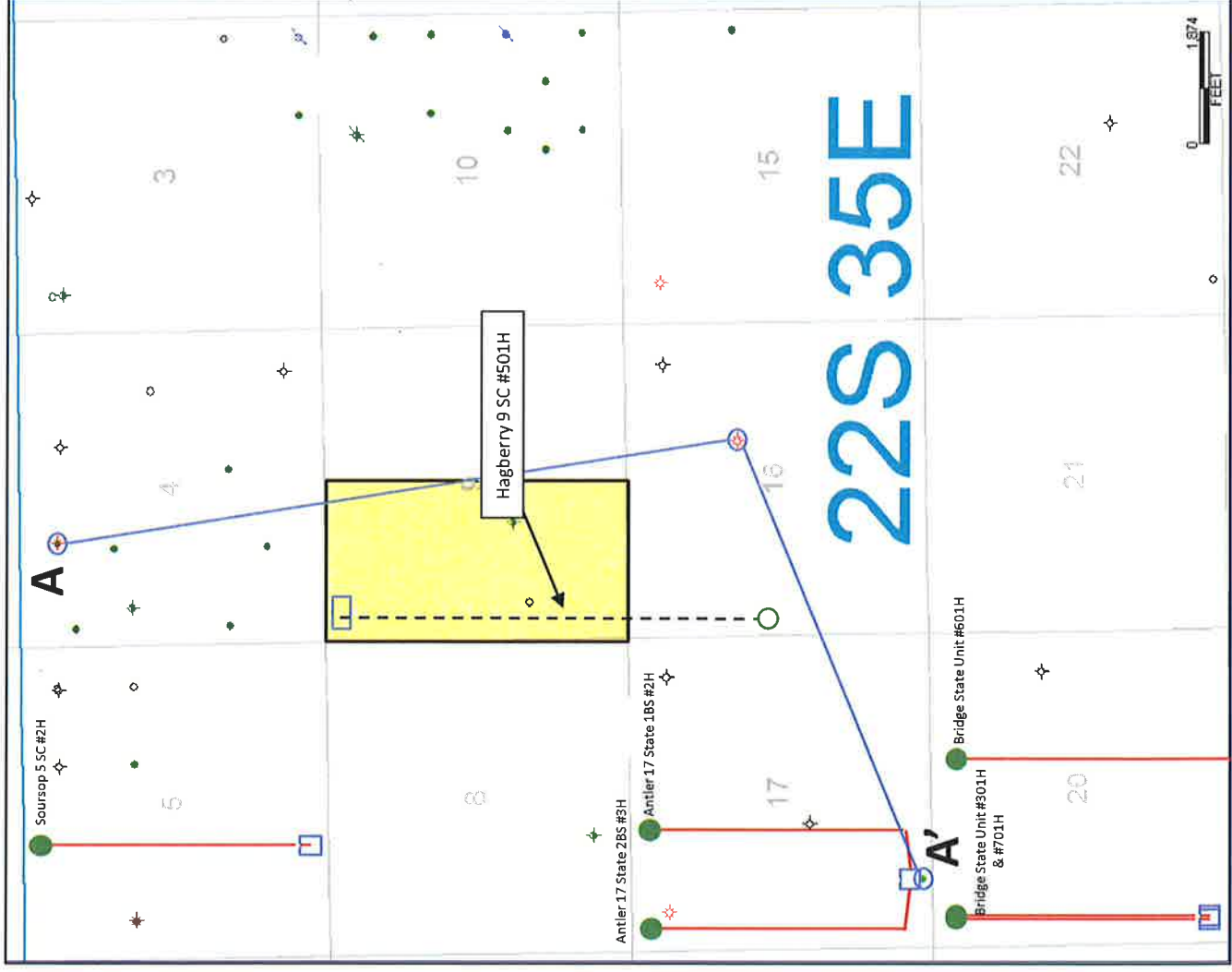
