**AFFIDAVIT OF KATIE DEAN**

Katie Dean, of lawful age and being first duly sworn, declares as follows:

1. My name is Katie Dean, and I am a Landman with Devon Energy Production Company, L.P. ("Devon"). I have previously testified before the New Mexico Oil Conservation Division as an expert witness in petroleum land matters, and my credentials have been accepted and made a matter of public record.
2. I am familiar with the application filed by Devon in this case and familiar with the status of the lands in the subject area.
3. None of the mineral owners to be pooled in this case have expressed opposition to this proceeding, so I do not expect any opposition at the hearing.
4. Devon seeks an order pooling all uncommitted interests in the Bone Spring formation (James Ranch; Bone Spring Pool (33840) & Ingle Wells; Bone Spring Pool (33740)) underlying a 960-acre standard horizontal spacing unit comprised of the W/2 of Sections 15, 22, and 27, Township 23 South, Range 31 East, NMPM, Eddy County, New Mexico. This standard horizontal spacing unit will be dedicated to two initial proposed wells to be drilled at a depth sufficient to test the Bone Spring formation from common surface hole locations in the NW/4 NW/4 (Unit D) of Section 15:

- **Maldives 15-27 Fed Com 231H Well** to be drilled from a surface hole location in the NW/4 NW/4 (Unit D) of Section 15 to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 27.
- **Maldives 15-27 Fed Com 232H Well** to be drilled from a surface hole location in the NW/4 NW/4 (Unit D) of Section 15 to a bottom hole location in the SE/4 SW/4 (Unit N) of Section 27.

5. The completed interval for the **Maldives 15-27 Fed Com 232H Well** will remain within 330 feet of the W/2 W/2 of Sections 15, 22, and 27 to allow inclusion of these proximity tracts in a standard 960-acre horizontal well spacing comprised of the W/2 of Sections 15, 22, and 27. Incorporating proximity tracts, these wells will comply with the Division's setback requirements.

6. **Exhibit No. 1-A** contains the Form C-102s for the proposed wells. Devon has been advised by the District Office that this horizontal spacing unit is located in two pools: (James Ranch; Bone Spring Pool (33840) & Ingle Wells; Bone Spring Pool (33740)).

7. **Exhibit No. 1-B** identifies the tracts of land comprising the proposed horizontal well spacing unit and identifies the ownership interests by tract. This proposed spacing unit includes only federal lands.

8. **Exhibit No. 1-C** identifies the tracts of land within the proposed horizontal spacing unit that are encompassed within the James Ranch; Bone Spring Pool (33840), and the tracts of land within the proposed horizontal spacing unit that are encompassed within the Ingle Wells; Bone Spring Pool (33740). Devon has highlighted on this exhibit the working interest owners that remain to be pooled in this proceeding. Devon also seeks to pool the overriding royalty interest owners identified on Exhibit 1-C.

9. No ownership depth severances or unleased mineral interests exist within the proposed spacing units.

10. **Exhibit No. 1-D** contains the well proposal letters and AFEs provided to the working interest owners Devon is seeking to pool. In addition to submitting these letters, Devon has undertaken good faith efforts to reach agreement with the mineral owners that it seeks to pool.

11. The costs reflected on each AFE are consistent with what Devon has incurred for drilling similar horizontal wells in the subject formation in this area.

12. Devon seeks approved overhead and administrative rates for the proposed wells at \$8,000 per month while drilling and \$800 per month while producing. These rates are consistent with what other operators are charging in this area for similar wells.

13. Devon has conducted a diligent search of county records and computer databases to locate addresses for the mineral owners it seeks to pool. I have provided the law firm of Holland & Hart LLP with these addresses and instructed that notice of this hearing be provided to the mineral owners Devon seeks to pool.

14. Exhibit Nos. 1-A through 1-D were either prepared by me or compiled under my direction and supervision.

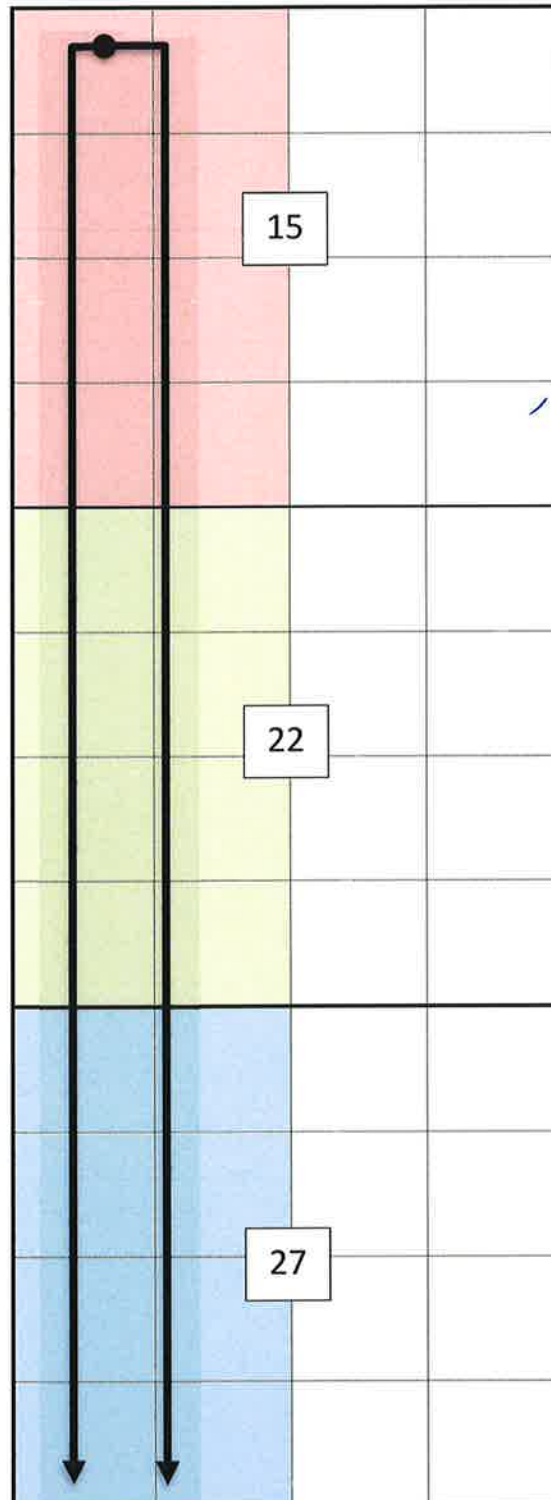

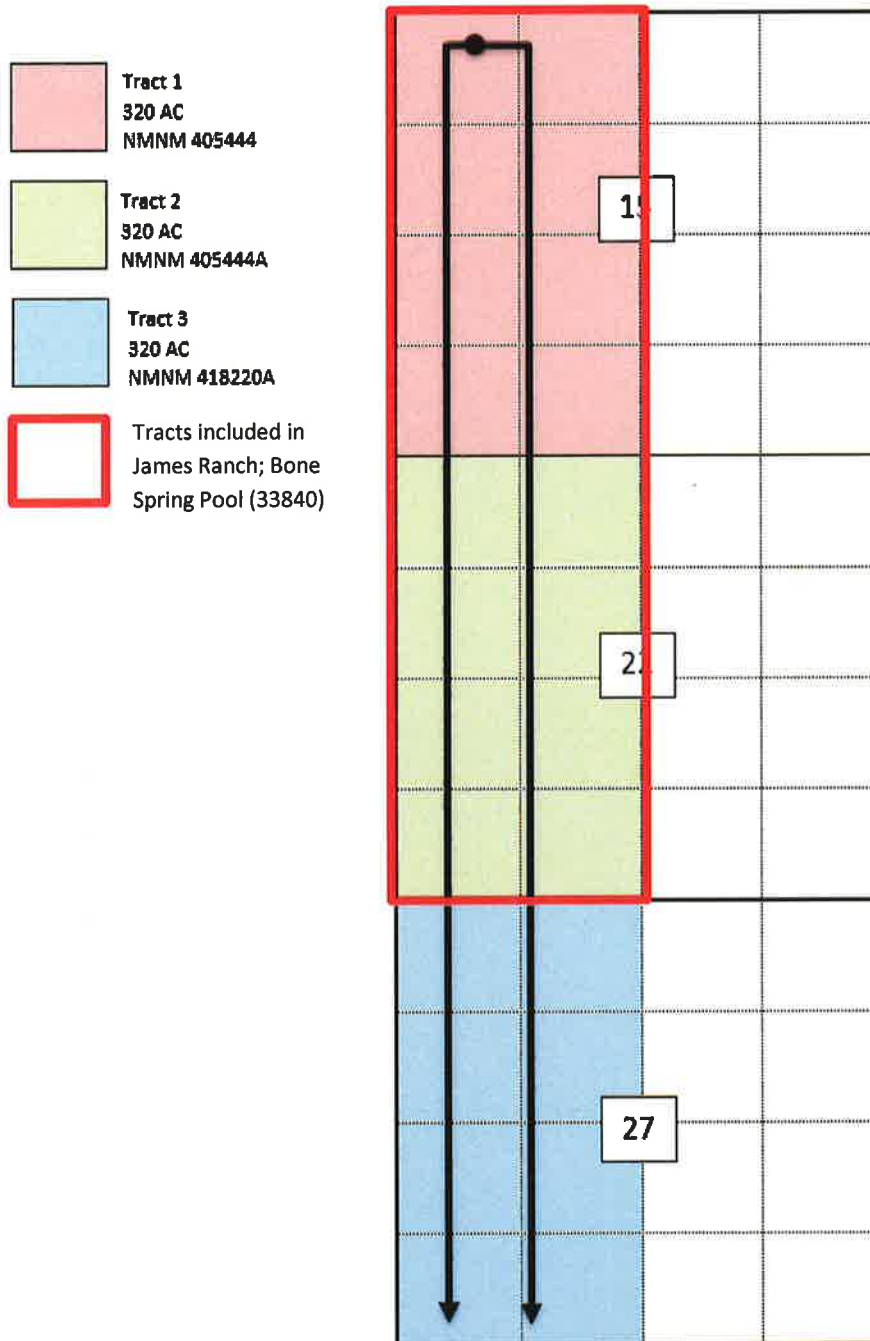

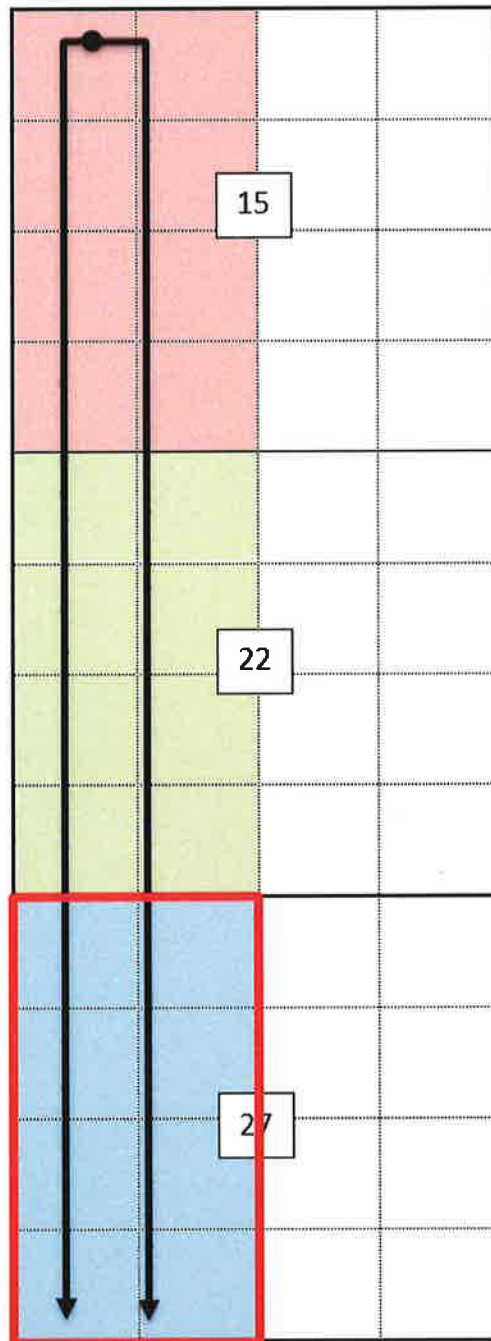

**AFFIDAVIT OF BRYAN CURRIE**

Bryan Currie, of lawful age and being first duly sworn, declares as follows:

1. My name Bryan Currie and I work for Devon Energy Production Company, L.P. ("Devon") as a geologist. I have previously testified before the New Mexico Oil Conservation Division as an expert witness in petroleum geology. My credentials as a petroleum geology have been accepted by the Division and made a matter of record.

2. I am familiar with the applications filed by Devon in these consolidated cases. Since Devon is targeting the Second Bone Spring sand interval with its proposed wells, I have conducted a geologic study of the Bone Spring formation underlying the subject acreage.

3. **Exhibit No. 2-A** is a structure map that I prepared for the base of the Second Bone Spring sand interval. The proposed wells are depicted with green lines and I have identified the first take point and the bottom hole location for each well. Existing producing wells in the Second Bone Spring interval are also shown on this map.

4. The structure map shows that the formation is gently dipping to the east in this area. I do not observe any faulting, pinch outs, or geologic impediments to developing the targeted interval with horizontal wells.

5. **Exhibit No. 2-B** identifies the three wells penetrating the targeted interval that I used to construct a stratigraphic cross-section from A to A'. I utilized these well logs because

they penetrate the targeted interval, are of good quality, and have been subjected to a petrophysical analysis of the targeted interval. In my opinion, these wells logs are representative of the geology in the area.

6. **Exhibit No. 2-C** is a stratigraphic cross section using the representative wells depicted on Exhibit 2-B. It contains a gamma ray, resistivity and porosity logs. The landing zone for both wells is labeled on the exhibit and highlighted with green shading. The cross-section demonstrates that the targeted interval extends across the proposed spacing units.

7. In my opinion, the north to south orientation of the proposed wells is the preferred orientation for horizontal well development in the targeted interval in this area. This slight standup orientation will efficiently and effectively develop the subject acreage.

8. Based on my geologic study, the targeted interval underlying the subject area is suitable for development by horizontal wells and the tracts comprising the proposed spacing units will contribute more-or-less equally to the production from the wellbores.

9. In my opinion, the granting of Devon's application will be in the best interest of conservation, the prevention of waste, and protection of correlative rights.

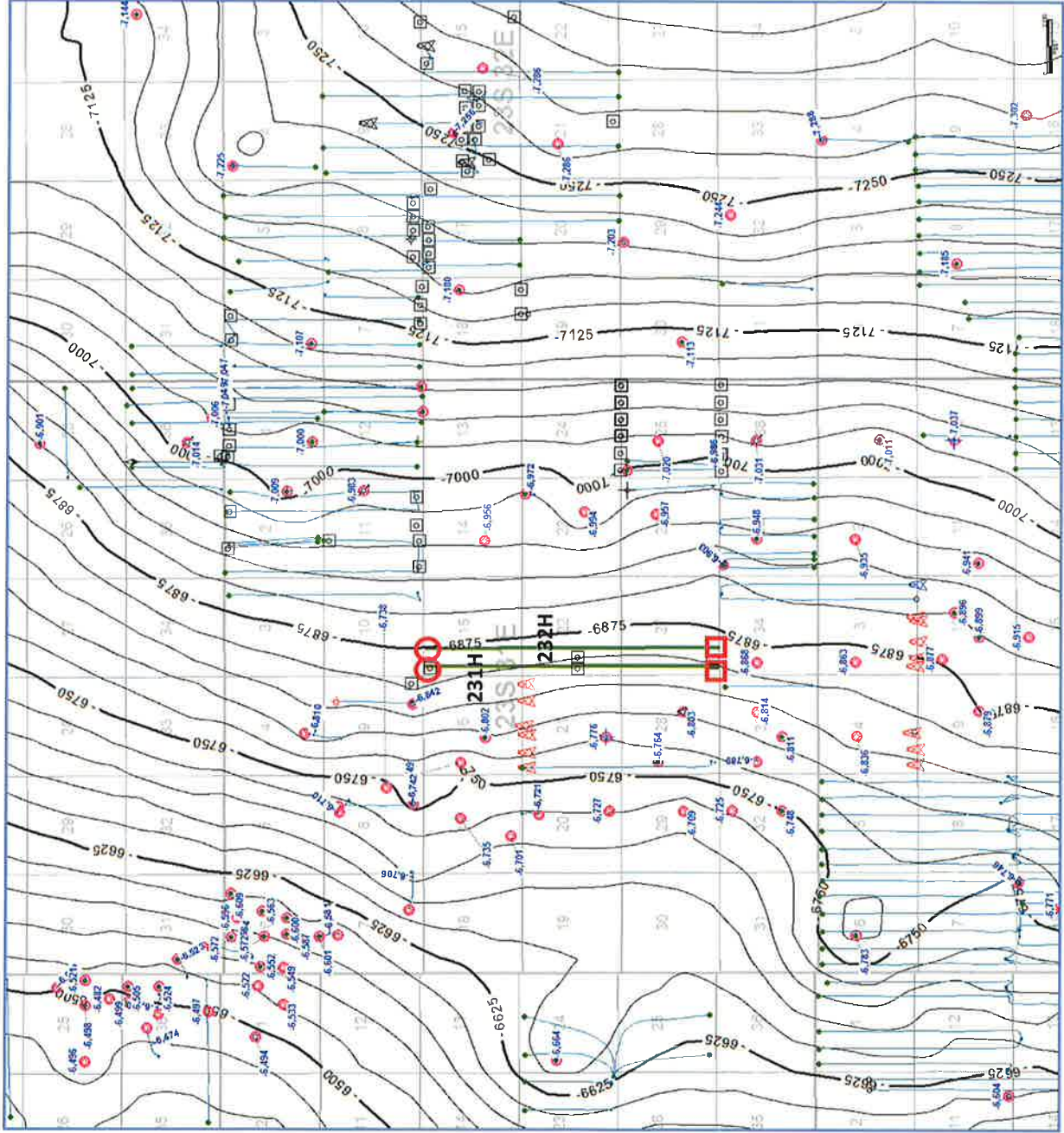

# Structure Map 3BSLM (Base of 2BSSS) CI = 25 Feet

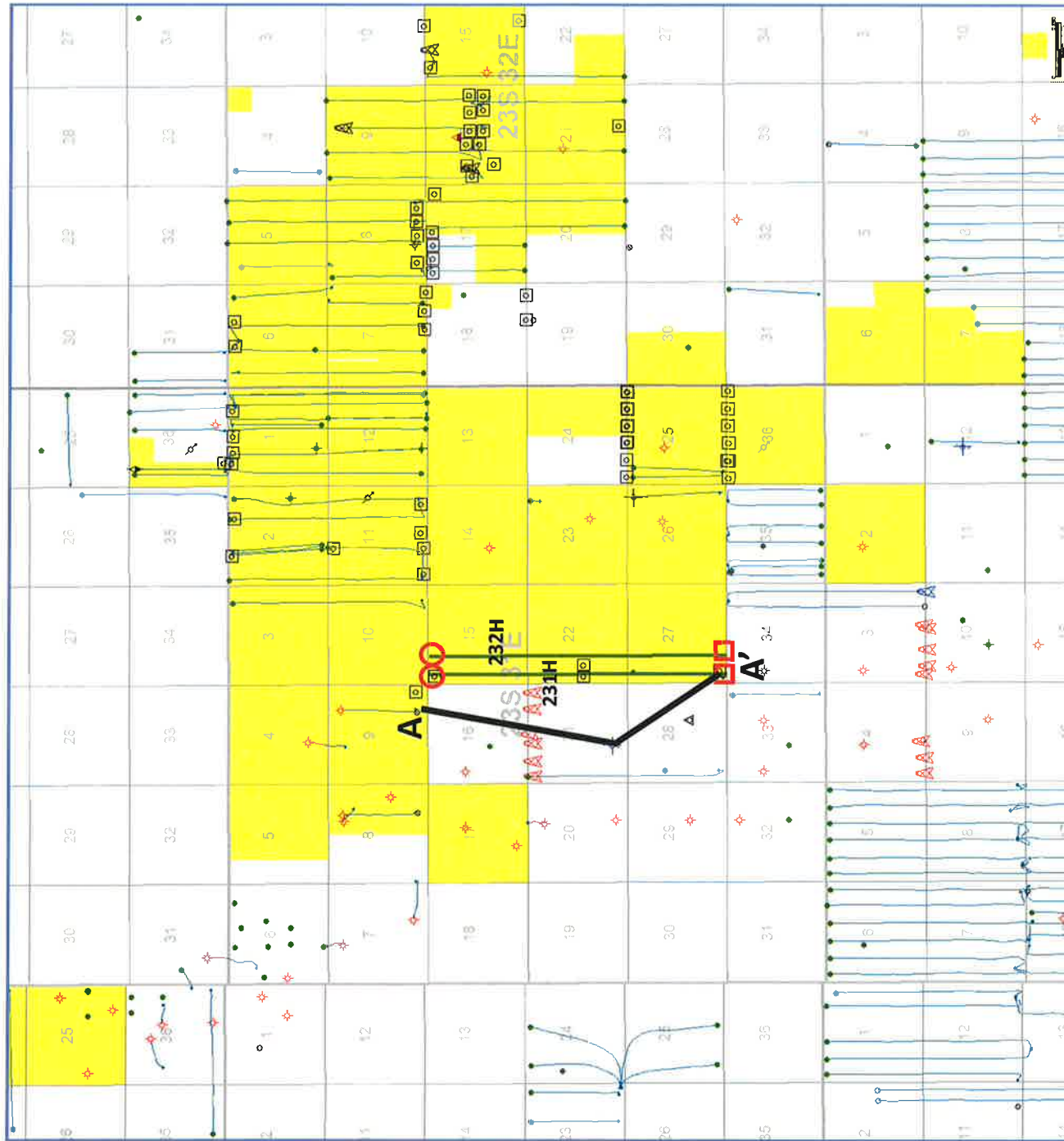

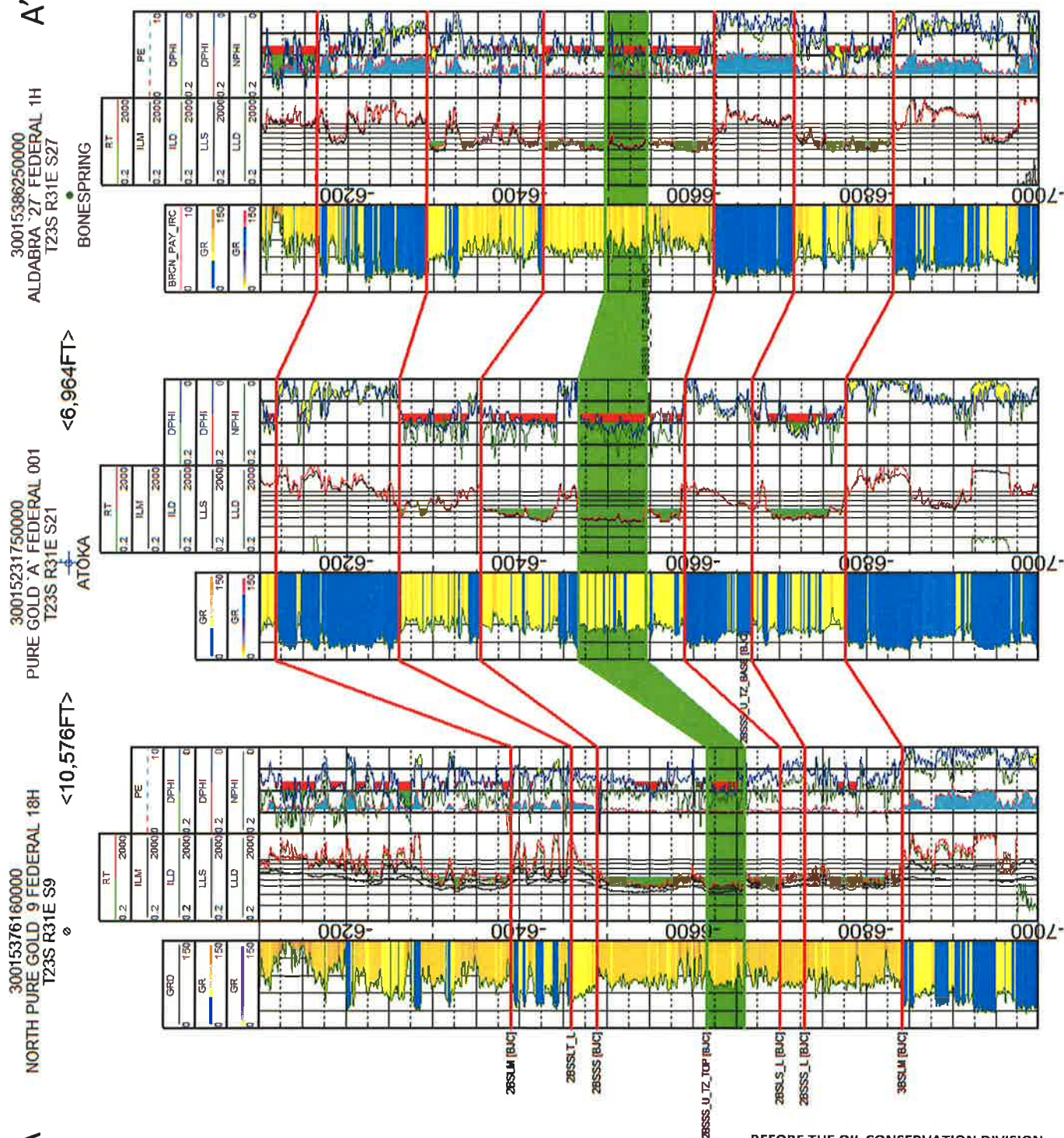

**Case No. 20528: Application of Devon Energy Production Company, L.P. for compulsory pooling, Eddy County, New Mexico.** Applicant in the above-styled cause seeks an order pooling all uncommitted interest owners in the Bone Spring formation underlying a 960-acre standard horizontal spacing unit comprised of the W/2 of Sections 15, 22, and 27, Township 23 South, Range 31 East, NMPM, Eddy County, New Mexico. Applicant seeks to dedicate the above-referenced horizontal spacing unit to two initial proposed wells: (1) the Maldives 15-27 Fed Com 231H Well, and (2) the Maldives 15-27 Fed Com 232H Well. These wells will be horizontally drilled from a common surface location in the NW/4 NW/4 (Unit D) of Section 15 to bottom hole locations in the SW/4 SW/4 (Unit M) and the SE/4 SW/4 (Unit N) of Section 27. The completed interval of the Maldives 15-27 Fed Com 232H Well will remain within 330 feet of the W/2 W/2 of Sections 15, 22, and 27 to allow inclusion of these proximity tracts into a standard 960-acre horizontal well spacing comprised of the W/2 of Sections 15, 22, and 27. Also, to be considered will be the cost of drilling and completing the wells, the allocation of the costs thereof, the actual operating costs and charges for supervision, the designation of the Applicant as operator, and the imposition of a 200% charge for risk involved in drilling and completing the well. Said area is located approximately 30 miles southeast of Carlsbad, New Mexico.
