2 EXAMINER DAWSON: Moving on to Case Number  
3 20502, application of Mewbourne Oil Company for  
4 compulsory pooling, Eddy County, New Mexico.

5 Please call for appearances.

6 MS. HARDY: Dana Hardy for Mewbourne.

7 MR. CARR: William Carr for COG Operating.

8 MR. BRUCE: Jim Bruce for ConocoPhillips  
9 Company.

10 EXAMINER DAWSON: When you're ready,  
11 Ms. Hardy.

12 MS. HARDY: Thank you.

13 Mewbourne's application seeks the pooling  
14 of all uncommitted interests in the Bone Spring  
15 Formation in a standard 400-acre horizontal spacing unit  
16 comprised of the south half of the north half of Section  
17 3, the south half of the north half of Section 4 and the  
18 south half of the northeast quarter of Section 5,  
19 Township 20 South, Range 30 East in Eddy County. The  
20 horizontal spacing unit will be dedicated to the Caballo  
21 Loco 5/3 B2GH Fed Com #4H well.

22 Exhibit 1 is a self-affirmed statement of  
23 landman Mitch Robb. The attachments to his affidavit  
24 include a Midland Map identifying the horizontal spacing  
25 unit, a chart of tract ownership, documents addressing

1 Mr. Robb's well proposals, notice of today's hearing and  
2 an AFE for the well. As Mr. Robb notes in his  
3 affidavit, there are no depth severances in the Bone  
4 Spring Formation. Mewbourne is requesting overhead and  
5 administrative rates of 800 a month and 8,000 a month,  
6 which are the same as the rates in Mewbourne's JOA for  
7 the well. And finally, Mewbourne is requesting a 200  
8 percent risk penalty.

9                   Exhibit Number 2 is a self-affirmed  
10 statement of geologist Charles Crosby. Attached to  
11 Mr. Crosby's affidavit are a structure map of the base  
12 of the Bone Spring Sand, a gross sand isopach map, a  
13 west-to-east cross section, a table containing  
14 information from other wells drilled in the vicinity and  
15 a survey calculation report for the proposed well. As  
16 stated in Mr. Crosby's affidavit, the horizontal spacing  
17 unit is justified from a geologic standpoint. A  
18 west-to-east or east-to-west orientation is preferred.  
19 There is no faulting or other geologic impediments that  
20 might adversely affect the drilling of the proposed  
21 well, and each quarter section of the proposed unit will  
22 contribute more or less equally to production.

23                   With that, I move the admission of Exhibits  
24 1 and 2.

25                   MR. CARR: No objection.

1 MR. BRUCE: No objection.

2 EXAMINER DAWSON: No objections?

3 So at this point, Exhibits 1 and 2 will be  
4 admitted to the record.

5 (Mewbourne Oil Company Exhibit Numbers 1  
6 and 2 are offered and admitted into  
7 evidence.)

8 EXAMINER DAWSON: Do you have any  
9 questions, Mr. Bruce?

10 MR. BRUCE: No, sir.

11 EXAMINER DAWSON: Mr. Carr?

12 MR. CARR: No.

13 EXAMINER DAWSON: Mr. Brooks?

14 EXAMINER BROOKS: Just a second here.

15 On GPC Oil Company, on your exhibit, you  
16 said you mailed the working interest -- mailed a working  
17 interest -- a well proposal and JOA to the listed party  
18 and received a signed AFE, so that interest is  
19 committed, right?

20 MS. HARDY: GPC is committed at this point.  
21 That's correct.

22 EXAMINER BROOKS: Okay. So although you  
23 attempt -- you were unable to subsequently attempt --  
24 attempt -- unable to complete a subsequent attempt to  
25 contact the owner, that would seem to be irrelevant

1 since they've already signed the JOA.

2 MS. HARDY: Since that date, that's  
3 correct.

4 EXAMINER BROOKS: Okay. Thank you.

5 MS. HARDY: Thank you.

6 EXAMINER DAWSON: That's all, David?

7 EXAMINER BROOKS: That's all.

8 EXAMINER DAWSON: That's all the questions  
9 we have.

10 MS. HARDY: Thank you.

11 I'd ask for the case to be taken under  
12 advisement.

13 EXAMINER DAWSON: Okay. At this time Case  
14 Number 20502 will be taken under advisement.

15 MS. HARDY: Thank you.
