STATEMENT OF CASE

Cimarex seeks an order for the pooling of all uncommitted mineral interests in the Bone Spring formation in a 640-acre standard horizontal spacing unit comprised of the W/2 of Section 34 and W/2 of Section 3, Township 26 South, Range 26 East, N.M.P.M., Eddy County, New Mexico for its proposed **Hayduke 34-3 Federal Com 8H, 9H, 10H, and 11H** wells, to be horizontally drilled. The producing area for these wells will be orthodox. Also to be considered will be the cost of drilling and completing said wells, the allocation of these costs as well as the actual operating costs and charges for supervision, designation of Cimarex as operator of the wells, and a 200% charge for risk involved in drilling said wells.
