**APPLICANT'S STATEMENT OF CASE**

COG seeks an order pooling all uncommitted interests in the Wolfcamp formation [Purple Sage; Wolfcamp (Gas) Pool] underlying a 640-acre horizontal spacing unit comprised of the E/2 of Sections 24 and 25, Township 24 South, Range 27 East, Eddy County, New Mexico. This horizontal spacing unit will be dedicated to the following proposed initial wells:

- The **Quien Sabe Fed Com No. 602H Well** to be horizontally drilled from a surface location in the NW/4 NE/4 (Unit B) of Section 24 to a bottom hole location in the SE/4 SE/4 (Unit P) of Section 25.

- The **Quien Sabe Fed Com No. 603H Well**, and the **Quien Sabe Fed Com 801H Well** to be horizontally drilled from a common surface location in the NW/4 NE/4 (Unit B) of Section 24 to bottom hole locations in the SW/4 SE/4 (Unit O) of Section 25.

Due to a change in COG's development plan, COG is no longer seeking to dedicate the following wells to this spacing unit: Quien Sabe Fed Com No. 601H, Quien Sabe Fed Com No. 701H, Quien Sabe Fed Com No. 702H Well, and Quien Sabe Fed Com No. 703H. The completed interval for these wells will remain within the standard setback as required by the Special Rules for the Purple Sage; Wolfcamp (Gas) Pool.
