MOTION FOR CONTINUANCE

COG OPERATING, LLC (COG), through its undersigned attorneys, hereby moves the Division for an order continuing the above-referenced case from the July 25, 2019 examiner hearing docket to a special hearing docket on September 3, 2019.

In this case, COG seeks an order pooling all uncommitted interests in the Bone Spring and Wolfcamp formations in a proposed horizontal spacing unit comprised of Lots 1, 2, 7, 8, 9 10, 15 and 16 and the SE/4 of Irregular Section 2, Township 21 South, Range 32 East, N.M.P.M., Lea County, New Mexico. This horizontal spacing unit will be dedicated to its proposed Cougar Federal Com 601H (Bone Spring formation) and its proposed Cougar Federal Com 701H and Cougar Federal Com 901H (Wolfcamp formation).
- ConocoPhillips Company ("COPC") and EOG Resources, Inc. ("EOG") own
 interests which are subject to this pooling application and each has filed an Entry of Appearance
 in this case.
- 3. COG's application was first scheduled for hearing on June 13 and, although the parties have been engaged in settlement discussions, no settlement agreement has been finalized.
 - 4. The application is currently set for hearing on July 25, 2019.
- 5. This case should take several hours to present and COG therefore requests that it be set for hearing on a special examiner hearing docket on September 3, 2019. COG has confirmed with the Division that this date is available for a special hearing.
- 6. Counsel for the parties have discussed this continuance and neither COPC nor EOG oppose COG's request.

WHEREFORE, COG OPERATING LLC. requests that Case 20489 be continued to a special examiner hearing docket on September 3, 2019.
