STATEMENT OF THE CASE

APPLICANT

CASE NO. 20657

Application of Milestone Environmental Services LLC, for approval of a salt water disposal well in Lea County, New Mexico. The proposed well is located within a ¼ mile of State Trust surface and mineral estate and will be injecting produced water into the Delaware Mountain Group.

OPPONENT NEW MEXICO STATE LAND OFFICE

The New Mexico State Land Office (SLO) is concerned with injection into the Delaware Mountain Group and the potential to cause waste. SLO is concerned with protection of known oil and gas within the Delaware Mountain Group (Bell Canyon, Cherry Canyon, and Brushy Canyon) and down to the Avalon Shale. This interval includes multiple oil and gas zones with viable horizontal drilling prospects.
