3. A true and correct copy of the C-102 for the Caballo Loco 5/3 B2GH Fed Com #4H well is attached as Exhibit A. The C-102 was not available when my Self-Affirmed Statement was introduced because Mewbourne was awaiting Division approval of a change of operator for the well and subsequently changed the well name.

4. The well location identified on the C-102 matches the well location that I identified in my well proposal letters and the evidence presented at the June 11, 2019 hearing.

5. I understand that this Self-Affirmed Statement will be used as written testimony in this case. I affirm that my testimony in paragraphs 1 through 4 above is true and correct and is made under penalty of perjury under the laws of the State of New Mexico. 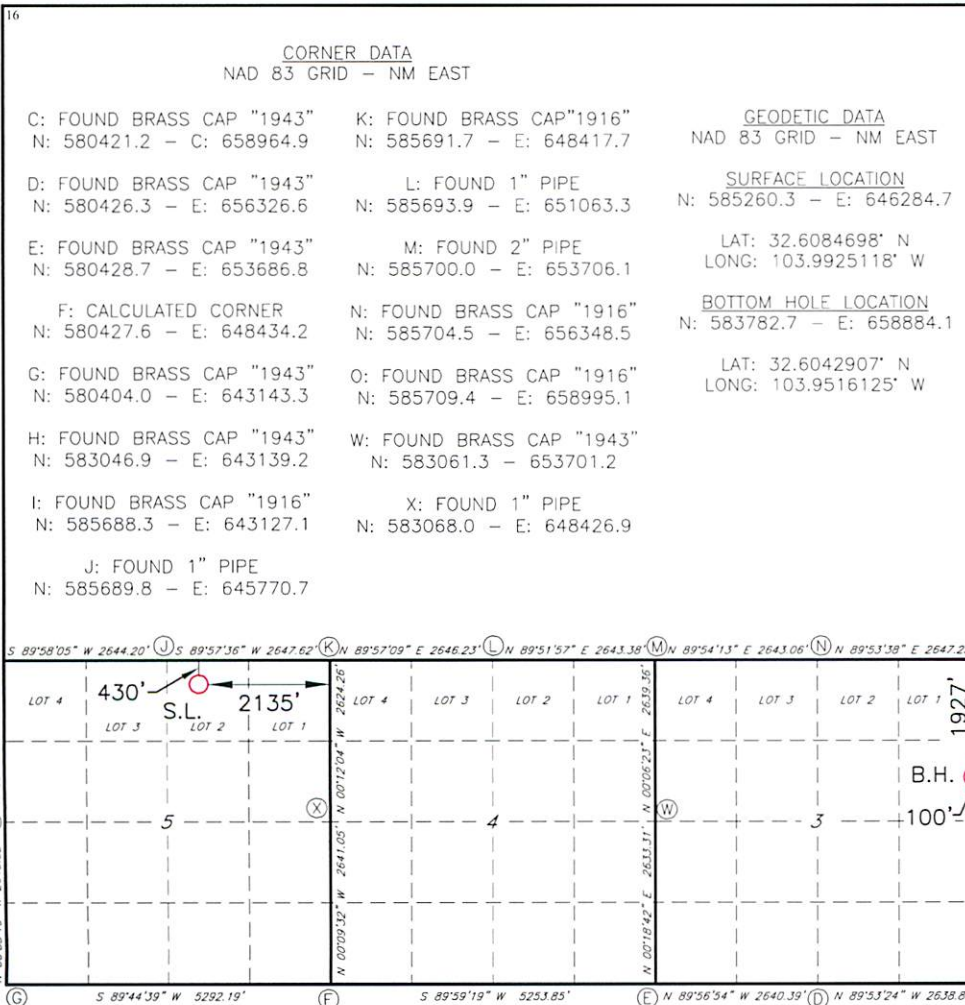

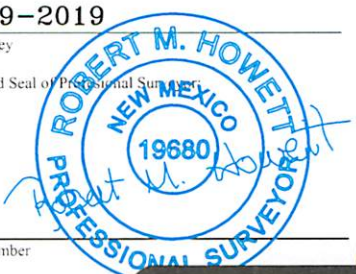
