I. REQUEST.

1. Ascent Energy, LLC ("Ascent") moves for a continuance of the hearing set in this case, and in the following related cases:

APPLICATION OF ASCENT ENERGY, LLC FOR COMPULSORY POOLING, EDDY COUNTY, NEW MEXICO.

Case No. 16482

APPLICATION OF APACHE CORPORATION FOR COMPULSORY POOLING AND APPROVAL OF A HORIZONTAL SPACING UNIT AND DEVEOPMENT AREA, EDDY COUNTY.

Case No. 20171

APPLICATION OF APACHE CORPORATION FOR COMPULSORY POOLING AND APPROVAL OF A HORIZONTAL SPACING UNIT AND DEVEOPMENT AREA, EDDY COUNTY.

Case No. 20202

In support thereof, Ascent states:

II. FACTS.

2. Ascent seeks the following in its cases:

Case No. 16481: Ascent seeks an order pooling all mineral interests in the Bone Spring formation underlying a 320-acre standup horizontal spacing comprised of the W/2W/2 of Section 28 and the W/2W/2 of Section 33, Township 20 South, Range 30 East, NMPM.

Case No. 16482: Ascent seeks an order pooling all mineral interests in the Wolfcamp formation underlying a 320-acre standup horizontal spacing unit comprised of the W/2W/2 of Section 28 and the W/2W/2 of Section 33, Township 20 South, Range 30 East, NMPM.

3. Apache Corporation ("Apache") seeks the following in its cases:

Case 20171: Apache seeks an order pooling all mineral interests (apparently in the Bone Spring formation) underlying an 800-acre laydown horizontal spacing comprised of the N/2 of Section 28, N/2 of Section 29, and NE/4 of Section 30, Township 20 South, Range 30 East, NMPM.

Case 20202: Apache seeks an order pooling all mineral interests (apparently in the Wolfcamp formation) underlying an 800-acre laydown horizontal spacing unit comprised of the N/2 of Section 28, N/2 of Section 29, and NE/4 of Section 30, Township 20 South, Range 30 East, NMPM.

4. Exhibit A shows Ascent's acreage in this area. <u>Please note</u> that Apache owns no interest in Section 28.

III. MOTION FOR A CONTINUANCE.

- 5. This matter is currently set for a special hearing on August 20, 2019.
- 6. Recently Ascent was recently able to obtain the services of a drilling rig, and has commenced drilling a number of its well locations in Southeast New Mexico.
- 7. Key Ascent personnel who are going to testify at the hearing need to be on the rig full time running operations while the wells are being drilled. Because Ascent is not a large company, it does not have replacements for these witnesses. As a result, all of its proposed witnesses cannot be present in Santa Fe next week, and Ascent seeks a continuance of the hearing.
- 8. In addition, the ads for the two Apache cases do not identify the formations being pooled; they only identify the acreage Apache requests to be pooled. Thus, in any event, its applications will need to be continued for notice purposes.
- 9. Mewbourne Oil Company does not oppose this request. The position of EOG Resources, Inc. is unknown.
 - 10. Apache opposes this motion.

WHEREFORE, Ascent requests that the hearing scheduled for August 20th be vacated and the matters be continued to September 19, 2019 so that a special date can be arranged for a date when Ascent's witnesses are available for hearing.


