APPLICANT'S STATEMENT OF CASE

Ameredev seeks an order (1) pooling all uncommitted interest in the Wolfcamp formation (Pool Code 33813) underlying a standard 640-acre, more or less, spacing unit comprised of the W/2 W/2 of Section 29, E/2 E/2 of Sections 30 and 31, and the W/2 W/2 of Section 32, Township 25 South, Range 36 East, N.M.P.M., Lea County, New Mexico, and (2) dedicating the above-referenced horizontal spacing unit to the proposed **Redbud Fed Com 25-36-32 121H Well**, which

will be horizontally drilled from a surface location in the NW/4 NW/4 (Unit D) of Section 5, Township 26 South, Range 36 East, to a bottom hole location in the NW/4 NW/4 (Unit D) of Section 29. The completed interval of the **Redbud Fed Com 25-36-32 121H Well** will remain within 330 feet of the section line separating: (1) the W/2 W/2 of Section 29 from the E/2 E/2 of Section 30, and (2) the W/2 W/2 of Section 32 from the E/2 E/2 of Section 31 to allow inclusion of this offsetting acreage into a standard 640-acre horizontal well spacing unit.
