APPLICANT'S STATEMENT OF CASE

In Case No. 20763, OXY seeks an order pooling all uncommitted interests in the Bone Spring formation (Pierce Crossing; Bone Spring (50371)) underlying a standard 640-acre, more or less, horizontal well spacing unit comprised of the E/2 of Sections 8 and 17, Township 24 South, Range 29 East, NMPM, Eddy County, New Mexico. OXY seeks to dedicate this spacing unit to the proposed initial **Oxbow CC 17-8 Fed Com No. 35H Well** (API No. 30-015-45087), which will be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) of Section 17 to a bottom-hole location in the NE/4 NE/4 (Unit A) of Section 8. The completed interval for the

Oxbow CC 17-8 Fed Com No. 35H Well will remain within 330 feet of the W/2 E/2 of Sections 8 and 17 to allow inclusion of these proximity tracts in a standard 640-acre horizontal well spacing comprised of E/2 of Sections 8 and 17.

In Case No. 20764, OXY seeks an order pooling all uncommitted interests in the Wolfcamp formation (Purple Sage; Wolfcamp (Gas) Pool (98220)) underlying a standard 640-acre, more or less, horizontal well spacing unit comprised of the E/2 of Sections 8 and 17, Township 24 South, Range 29 East, NMPM, Eddy County, New Mexico. OXY seeks to dedicate this spacing unit to the following proposed initial wells:

- The Oxbow CC 17-8 Fed Com #34H Well (API No. 30-015-45086), which will be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) of Section 17 to a bottom-hole location in the NW/4 NE/4 (Unit B) of Section 8.
- The Oxbow CC 17-8 Fed Com #36H Well (API No. 30-15-45088), which will be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) of Section 17 to a bottom-hole location in the NE/4 NE/4 (Unit A) of Section 8.
- The Oxbow CC 17-8 Fed Com #38H Well (API No. pending), which will be horizontally drilled from a surface location in the SE/4 SW/4 (Unit N) of Section 17 to a bottom-hole location in the NW/4 NE/4 (Unit B) of Section 8.
