- 23 back?
- 24 MR. HALL: Well, I'll explain. If you'll
- 25 refer to the new exhibit packet, Exhibit B1 is the

1 affidavit of the geologist, Trevor Gates. At the time

- of the last hearing, I did not have a signed copy; I
- 3 didn't have a signature for him. So I'm substituting
- 4 this version, which does have a signature for that one.

- 17 That's all I have. I move the admission of
