STATEMENT OF THE CASE

Mewbourne Oil Company ("Applicant") seeks an order pooling all mineral interests in the Wolfcamp formation (Wildcat; Wolfcamp; Oil Pool) underlying a 320 acre, more or less, horizontal spacing unit comprised of the N/2 S/2 of Section 31 and the N/2 S/2 of Section 32, Township 20 South, Range 29 East, NMPM, Eddy County, New Mexico. The unit will be dedicated to the **Normandy 31/32 WOLI Federal Com #1H** well to be drilled to a depth sufficient to test the Wolfcamp formation from a surface hole location in the NW/4 SW/4 (Lot 3) of Section 31 (2579' FSL and 355' FWL), with a first take point 2200' FSL and 100' FWL of Section 31, and a final take point in the NE/4 SE/4 (Unit I) of Section 32 (2200' FSL and 100'

FEL). Also to be considered are Applicant's designation as the operator of the spacing unit and the wells, the cost of drilling and completing the wells and allocation of the costs thereof, as well as the actual operating charges and costs of supervision, and imposing a 200% charge for the risk assumed by Applicant in drilling and completing the wells.
