**APPLICANT'S STATEMENT OF CASE**

COG seeks an order: (1) pooling all uncommitted interests in the Bone Spring formation underlying a standard 322.08-acre, more or less, horizontal spacing unit comprised of the W/2 W/2 of irregular Sections 30 and 31, Township 25 South, Range 28 East, NMPM, Eddy County, New Mexico; and (2) dedicating the above-referenced horizontal spacing unit to the proposed initial **Myox 6 State Com #510H well** (API No. 30-015-45967) to be drilled from a surface hole location in NW/4 NW/4 (Lot 1) of irregular Section 6, Township 26 South, Range 28 East, to a bottom hole location in the NW/4 NW/4 (Lot 1) of Section 30. The completed interval for the proposed **Myox 6 State Com #510H well** will comply with statewide setbacks for horizontal oil wells.


