# STATEMENT OF THE CASE

### **APPLICANT**

Mewbourne Oil Company seeks an order pooling all mineral interests in the Wolfcamp formation in a horizontal spacing unit comprised of the N/2 of Section 31 and the N/2 of Section 32, Township 22 South, Range 27 East, NMPM. The unit will be dedicated to: (a) the Sundown 31/32 W0DA Fee Well No. 1H, with a first take point in the NW/4NW/4 of 31 and a final take point in the NE/4NE/4 of Section 32; (b) the Sundown 31/32 W0EH Fee Well No. 2H, with a first take point in the SW/4NW/4 of 31 and a final take point in the SE/4NE/4 of Section 32; and (c) the Sundown 31/32 W0EH Fee Well No. 3H, with a first take point in the SW4NW/4 of 31 and a final take point in the SE/4NE/4 of Section 32. Also to be considered will be the cost of drilling and completing the wells and the allocation of the cost thereof, as well as actual

operating costs and charges for supervision, designation of applicant as operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.
