**APPLICANT'S STATEMENT OF CASE**

XTO seeks an order pooling all uncommitted interests in the Bone Spring formation (Wildcat Bone Spring pool) underlying a standard 98.6-acre, more or less, horizontal spacing unit comprised of Lots 1-4 (S/2 N/2 equivalent) of irregular Section 32, Township 26 South, Range 30 East, NMPM, Eddy County, New Mexico. The horizontal spacing unit will be dedicated to the proposed **Stan 32 State #71H Well**, to be horizontally drilled from a surface location in the SE/4 NE/4 (Lot 1) of Section 32 to bottom hole location in the SW/4 NW/4 (Lot 4) of Section 32.

The completed interval for the proposed **Stan 32 State #71H Well** will comply with the Division's statewide setback requirements for oil wells.
