STATEMENT OF THE CASE

COG Operating LLC (COG), seeks an order pooling all uncommitted interests in the Wolfcamp formation, Purple Sage-Wolfcamp Gas Pool (Pool Code 98220) underlying the 767.51-acre, more or less, horizontal spacing unit comprised of the W/2 of Sections 20 and 29 and the N/2NW/4 and Lots 1 and 2 of irregular Section 32, Township 26 South, Range 28 East, NMPM, Eddy County, New Mexico. This horizontal spacing unit will be dedicated to the following two initial wells to be drilled simultaneously. The proposed **Honey Graham State Com 702H** to be horizontally drilled to a depth sufficient to test the Wolfcamp formation with the first take point for this well in Unit C (NE4NW/4) of Section 20 and the last take point in Lot 2 of Section 32; and the proposed **Honey Graham State Com 703H** to be horizontally drilled to a depth sufficient to test the Wolfcamp formation with the first take point for this well in Unit D (NW4NW/4) of Section 20 and the last take point in Lot 1 of Section 32.

All take points in each of the two initial wells shall be at legal locations pursuant to the rules of the Purple Sage-Wolfcamp Gas Pool. Also to be considered will be approval of an extension of time for the drilling and completion of the initial wells on this horizontal spacing unit, the cost of drilling and completing each well and the allocation of costs thereof, as well as actual operating costs and charges for supervision, designation of COG Operating LLC as operator of the wells and horizontal well unit, and a 200% charge for risk involved in the drilling and completing the wells.


