Shelly Albrecht, being duly sworn, deposes and states:

1. I am over the age of 18, I am the Director of Land for Franklin Mountain Energy, LLC (“Franklin”), and I have personal knowledge of the matters stated herein. I have previously testified before the Oil Conservation Division (“Division”) and I have been qualified by the Division as an expert petroleum landman.


2. My area of responsibility at Franklin includes the area of Lea County in New Mexico.

3. I am familiar with the applications filed by Franklin in these cases.

4. I am familiar with the status of the lands that are subject to the applications.

5. I submit the following information pursuant to NMAC 19.15.4.12.A(1) in support of the above referenced compulsory pooling applications.

6. The purpose of the applications is to force pool working interest owners into the horizontal spacing units described below, and in the wells to be drilled in the units.



7. No opposition is expected because the interest owners being pooled have been contacted regarding the proposed wells, but have failed or refused to voluntarily commit their interests in the wells.

8. The spacing units and wells that Franklin is proposing in these cases are part of a comprehensive development plan, covering the entirety of Sections 2 and 11 Township 25 South, Range 35 East, NMPM, Lea County, New Mexico. These cases, along with case 20951, cover the W/2 of the Sections. Case numbers 20982, 20983, and 20984 cover the E/2 of the Sections, and those cases are set for hearing on January 9, 2020. It is Franklin's intent to fully and efficiently develop the entirety of both Sections under its comprehensive development plan. The Development Overview is attached as **Exhibit 1**

9. In Case No. 20952, Franklin seeks an order from the Division pooling all uncommitted mineral interest within a Wolfcamp horizontal spacing unit underlying the E/2 W/2 of Sections 2 and 11, Township 25 South, Range 35 East, NMPM, Lea County, New Mexico. This spacing unit will be dedicated to the Blue Ribbon Fed Com 702H well and Blue Ribbon Fed Com 703H well. The Application is attached hereto as **Exhibit 2**.

10. In Case No. 20953, Franklin seeks an order from the Division pooling all uncommitted mineral interest within a Wolfcamp horizontal spacing unit underlying the W/2 W/2 of Sections 2 and 11, Township 25 South, Range 35 East, NMPM, Lea County, New Mexico. This spacing unit will be dedicated to the County Fair Fed Com 701H well. The Application is attached hereto as **Exhibit 3**.

11. Attached as **Exhibit 4** are the proposed C-102s for the wells.

12. The C-102s identify the proposed surface hole locations and bottom hole locations. The C-102s also identify the pool and pool code.

13. These wells will develop the WC-025-G-09-S253302D-Upper Wolfcamp Pool, Pool Code WC-98187.

14. This pool is an oil pool with 40-acre building blocks.

15. This pool is governed by the state-wide horizontal well rules.

16. The proposed first take point for the Blue Ribbon Fed Com 702H well is 643' FNL and 1743' FWL and the proposed last take point is 150' FSL and 1740' FWL. The producing interval for the well will be orthodox and will comply with the Division's set back requirements.

17. The proposed first take point for the Blue Ribbon Fed Com 703H well is 693' FNL and 2609' FWL and the proposed last take point is 150' FSL and 2610' FWL. The producing interval for the Blue Ribbon Fed Com 703H well will be unorthodox and will not comply with the Division's set back requirements. Franklin has applied for administrative approval of the non-standard location.

18. The proposed first take point for the County Fair Fed Com 701H well is 642' FNL and 354' FWL and the proposed last take point is 150' FSL and 350' FWL. The producing interval for the well will be orthodox and will comply with the Division's set back requirements.

19. **Exhibit 5** includes a lease tract map outlining the two units being pooled. Exhibit 5 also includes the parties being pooled and the percent of their interests.

20. There are no depth severances within the proposed spacing units.

21. I have conducted a diligent search of the public records in the county where the wells are located, and conducted phone directory and computer searches to locate contact information for parties entitled to notification, and mailed the working interest owners and unleased mineral owners well proposals, including an Authorization for Expenditure.

22. In our search, we identified several unprobated interests. We attempted to find the heirs by internet searches, phone directory searches, and searches of other publicly available information. We sent proposal letters to the addresses we were able to find for possible heirs.

23. I am continuing to work with unleased parties. Should any of the unleased parties choose to commit their interests to these wells, I will alert the Division of such developments.

24. Additionally, I have engaged in correspondence with uncommitted working interest owner Chief Capital (O&G) II, LLC on multiple occasions and will continue to do so in an effort to reach a mutually agreeable Operating Agreement. Should this uncommitted working interest party choose to commit their interest to these wells, I will alert the Division of such developments.

25. In my opinion, Franklin has made a good faith effort to obtain voluntary joinder of the working interest owners in the proposed wells.

26. Franklin seeks to pool overriding royalty interest owners, and they were provided notice of this hearing.

27. **Exhibit 6** is the well proposal letter that I sent to all working-interest owners. The proposal letter identifies the proposed surface hole and bottom hole locations and approximate TVD.

28. **Exhibit 7** contains the Authorization for Expenditure for the proposed wells. The estimated cost of the wells set forth therein is fair and reasonable, and is comparable to the costs of other wells of similar depths and length drilled in this area of New Mexico.

29. Franklin requests overhead and administrative rates of \$7000.00/month for drilling a well and \$700.00/month for a producing well. These rates are fair, and comparable to the rates charged by other operators for wells of this type in this area of Southeastern, New Mexico. Franklin requests that these rates be adjusted periodically as provided in the COPAS Accounting Procedure.

30. Franklin requests the maximum cost plus 200% risk charge be assessed against non-consenting working interest owners.

31. Franklin requests that it be designated operator of the well.

32. Franklin requests that it be allowed a period of one (1) year between when the wells are drilled and when the first well is completed under the order.

33. The parties Franklin is seeking to pool were notified of this hearing.

34. **Exhibit 8** is an affidavit of notice prepared by counsel for Franklin that shows the parties who were notified of this hearing, the status of whether they received notice, and an affidavit of publication from the Hobbs News-Sun newspaper, showing that notice of this hearing was published on December 1, 2019.

35. The attachments to this affidavit were prepared by me, or compiled from company business records, or were prepared at my direction.

36. I attest that the information provided herein is correct and complete to the best of my knowledge and belief.

37. In my opinion, the granting of this application is in the interests of conservation and the prevention of waste.



Franklin Mountain Energy, LLC (“FME”), OGRID Number 373910, through its undersigned attorneys, hereby makes an application to the Oil Conservation Division (“Division”) pursuant to the provisions of NMSA (1978), Section 70-2-17, for an order pooling all uncommitted mineral interests within a Wolfcamp horizontal spacing unit underlying the E/2W/2 of Sections 2 and 11, Township 25 South, Range 35 East, NMPM, Lea County, New Mexico

In support of this application, FME states as follows:

1. FME is an interest owner in the subject lands and has a right to drill a well thereon.
2. FME seeks to dedicate the E2W/2 of Sections 2 and 11, Township 25 South, Range 35 East, NMPM, Lea County, New Mexico to form a 320-acre, more or less, spacing unit.
3. FME plans to drill the **Blue Ribbon Federal 702H** and the **Blue Ribbon Federal 703H** wells to a depth sufficient to test the Wolfcamp formation. The wells will be horizontally drilled.
4. The Blue Ribbon Federal 703H well will not comply with the Division’s setback requirements. FME will apply for administrative approval of the non-standard well locations separately.

5. The Blue Ribbon Federal 702H will be drilled at orthodox locations under the Division's rules.

6. FME sought, but has been unable to obtain, a voluntary agreement from all interest owners in the Wolfcamp formation underlying the proposed spacing unit to participate in the drilling of the wells or to otherwise commit their interests to the wells.

7. The pooling of all interests in the Wolfcamp formation underlying the proposed unit will prevent the drilling of unnecessary wells, prevent waste and protect correlative rights.

8. FME further requests that it be allowed one (1) year between the time the first well is drilled and completion of the wells under the order issued by the Division.

WHEREFORE, FME requests this application be set for hearing before an Examiner of the Oil Conservation Division on December 12, 2019, and after notice and hearing as required by law, the Division enter its order:

A. Pooling all mineral interests in the Wolfcamp formation underlying a horizontal spacing unit within the E/2W/2 of Sections 2 and 11, Township 25 South, Range 35 East, NMPM, Lea County, New Mexico;

B. Designating FME as operator of this unit and the wells to be drilled thereon;

C. Authorizing FME to recover its costs of drilling, equipping and completing the wells;

D. Approving actual operating charges and costs charged for supervision, together with a provision adjusting the rates pursuant to the COPAS accounting procedure;

E. Setting a 200% charge for the risk involved in drilling and completing the wells in the event a working interest owner elects not to participate in the wells;

F. Allowing a time period of one (1) year between when the first well is drilled and completion of the wells under the order issued by the Division.

F. Allowing a time period of one (1) year between when the well is drilled and completion of the well under the order issued by the Division.



20. The preferred well orientation in this area is either north/south or south/north. This is because the  $S_{Hmax}$  is at approximately 265 degrees in in this area of Lea County.






- Red box shows the location of County Fair/Blue Ribbon development
- Planned wells are located on the western edge of the Capitan Reef




# Upper Wolfcamp Gross Interval Isochore Map


