MOTION FOR CONTINUANCE

Applicant Lucid Energy Delaware, LLC (“Lucid”) moves for a continuance of the hearing in this case. In support of its motion, Lucid states:

1. This case is currently scheduled to be heard on January 16, 2020.
2. Lucid has been engaging in discussions with Matador Production Company, MRC Permian Company, and EOG Resources, Inc. regarding Lucid’s proposed Red Hills AGI #2 well, and is requesting a continuance to give the parties an opportunity to continue their discussions. In addition, counsel for Lucid is scheduled to attend a hearing before the New Mexico Public Regulation Commission from January 6 through 16, 2020 and is unavailable for the January 16th hearing.
3. Lucid has contacted counsel for the Oil Conservation Division, Matador Production Company, MRC Permian Company, and EOG Resources, Inc. regarding this motion. Counsel for Matador Production Company, MRC Permian Company, and EOG Resources, Inc. does not oppose the motion. Lucid was unable to ascertain the position of counsel for the Oil Conservation Division.
4. WHEREFORE, Lucid requests that the Commission (i) grant this motion, and (ii) continue the hearing in this matter to the Commission’s February 27, 2020 docket.


